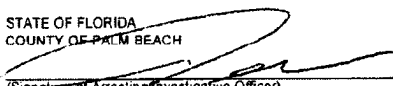

While attempting to place Leslie Wiles into arrested she pulled away and began yelling at us. D/S N. Smith (7871) and I had to pin Leslie to the rear bench seat of our vessel. Leslie was physically resisting by at actively pulling her hands away from us and kicking at us. During this time she kicked me in the groin area. She continued to resist and it some time to place handcuffs on her. During this time several commands were given to her to stop resisting. Once handcuffs were applied, we stood her up. While standing her up, she kicked Sgt. Farrugia (7023) in the leg. At this time we took her to the deck to gain control. She was extremely non-compliant and continued to resist. Sgt. Farrugia moved Leslie to the front of the vessel. At the front of the vessel she continued to be non-compliant and resisting. After being seated she continued to resist and attempted to stand. I held her hand and arm against the back of the seat to keep her from standing as she was transported to Phil Foster Park. Based on my investigation Leslie Wiles had violated F.S.S. 784.07(2)(b) Battery on Law Enforcement Officer and F.S.S. 843.01 Resisting with violence.

On 05-26-19 at approximately 1656 hours, DUI Enforcement Investigator Frey 9658 was effecting an arrest upon Leslie Erin Wiles for Boating under the Influence after she completed the Seated Battery Tasks. Inv. Frey informed Leslie she was under arrest for the above when she began to resist arrest by pulling away from him as she screamed at us that she was not drunk.												
Investigator Frey and Marine Deputy N. Smith 7871 pinned Leslie to the vessel rear bench seat. Leslie was kicking her legs and kicked Investigator Frey in the groin area. I pinned her ankles to the seat, Deputy Smith was holding her shoulders while Investigator Frey placed Leslie in handcuffs. I told Leslie to stop resisting and that she was being recorded. As we stood her up on her feet, she continued to be argumentative and non-compliant not following our instructions to stop resisting.												
Leslie kicked me in the leg, at which time I took her to the deck of the patrol vessel. Leslie continued screaming at us and not following instructions. I pinned her head and shoulder as she continued to resist and was extremely non-compliant.												
Once she calmed down we stood her up move her to the front of the vessel. We sat Leslie on the front console bench seat. Leslie again became argumentative and attempted to stand up when I made her sit on the seat and held her shoulder against the back of the seat. Leslie would not calm down, remained argumentative, therefor I had to hold onto her arm for the transport to Phil Foster Park.												
My investigation revealed Leslie committed Resisting Arrest with Violence and Battery on a Law Enforcement Officer per Florida Statutes 843.01 and 784.07 (2b), respectively.

On 26May19 at approximately 1634hrs I was on patrol with PBSO Marine Patrol in the area of Peanut Island, in the city of Rivera Beach, Palm Beach County. I was on Patrol with Sgt. D Farrugia (7023) and D/S N. Smith (7871).

We observed a yellow motorboat on plane coming from the north channel in a slow speed no wake zone. We conducted a vessel stop. As we tied up to the vessel I observed two cups of a pink beverage on the center console in front of the vessel operator.

OBSERVATION OF DRIVER:

As I made contact with the vessel operator I could smell the strong odor of an unknown alcoholic beverage coming from her person and her breath. Her speech was slurred and raspy. I asked her to remove her sunglasses; her eyes were watery and very bloodshot. She was identified by her U.S. Passport as Leslie Erin Wiles. I had her embark on to our vessel to perform Stand Field Sobriety Task (seated battery). I asked her to sit down to perform the task she refused to sit and stated she could do them standing. I explained to her the task had to be completed in a seated position. She eventually sat down.

Strong odor of an unknown alcoholic beverage coming from her breath

GENERAL OBSERVATIONS

SPEECH: slurred and raspy

ATTITUDE: excited, fidgety, combative, belligerent, fighting, aggressive

MEDICAL/OTHER: I asked her if she had any medical problems. She told me she had issues with her hips popping out of joint (approximately 20 years ago), an issue with her lungs, and issues with her herniated discs in her back.

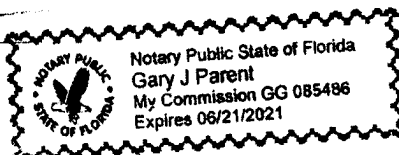

Other Observations:

I checked her eyes for Horizontal Gaze Nystagmus (HGN). Her eyes were watery and very bloodshot. She had difficulty following without moving her head and I had to remind her to keep head still. During the task she kept her arms braced at her side and leaned forward to maintain her balance while sitting. In both eyes she had lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and on the onset of nystagmus prior to 45 degrees. She did not have Vertical Gaze Nystagmus or Lack of Convergence. The task was completed seated in a stable position.

FINGER TO NOSE:

I instructed and demonstrated the finger to nose; she acknowledged she understood. She mimicked my movements during the instructions and demonstration. She had difficulty sitting still and was fidgety. She kept interrupting me and was yelling at her passenger, Stephany Lobban, to record the event. On her first command she placed the pad of her left finger at the bottom of her nose. On the second command she searched for her nose and touched the underside of her nose with the pad of her finger. On the third command she touched the tip of her nose with the pad of her finger. On the fourth command she touched her nose with the pad of her finger. On the fifth command she touched her nose with the pad of her finger. On the sixth command she touched the bridge of her nose with the pad of her finger. The task was completed seated in a stable position.

PALM PAT:

I instructed and demonstrated the palm pat; she acknowledged she understood. I had to reminder her to speed up. She chop pat, double pat, and rolled her hands. Towards the end she was clapping. The task was completed seated in a stable position.

HAND COORDINATION:

I instructed and demonstrated the hand coordination; she acknowledged she understood. I instructed her to place her hands in the instructional position; she had difficulty placing the correct hand on her chest. She stood up and wanted to complete the task standing. I asked her to sit down and explained to her the task needed to be completed in the seated position. She eventually sat down. As I was giving the instructions she would interrupt me. She began the task before being instructed. As she attempted the task she was unable to make contact with her hands on the first phase, on the second task she clapped 4 times and returned her hands to the incorrect position, the third task she walked her hands back towards her chest and when she brought her hands to her chest she placed her right hand flat on top of her left hand, and on the fourth task she slapped her hands on her legs and whipped her head back. I instructed the task again and she again acknowledged she understood. She placed her hands in the incorrect position and I to instruct her several times to place her hands in the correct position. She eventually was able to get her hand in the correct position. On the first task she moved her hands away from her chest and walked her hands 3 steps away from her chest. On the second task she clapped her hands she clapped her hand 4 times and brought her hands back to the incorrect position. On the third task she walked her hands back failing to make contact on each step. On the fourth task she slapped her hands on her thighs and whipped her head back. The task was completed seated in a stable position.

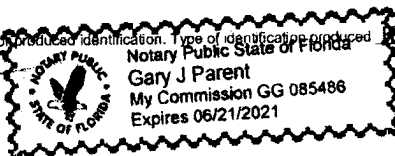
