On the 9th day of October	20 19 at 080				•	,

Victim, Norma Capian, stated on 8/17/2019 she looked in her jewelry box and found that two of her gold bracelets were missing. She last used them on 8/7/2019. Capian said no one else has been inside her home other than her cleaning service on 8/14/2019. Capian said the service is called Siga Services (561-626-8268) and she speaks to Denise or Carlos. Capian said the two females that came to her home to clean on 8/14/19 were Leila and Maria and that they have both been to her home before.

Capian stated her jewelry box sits on top of the dresser in her master bedroom and described the bracelets as follows: 1 yellow gold tennis bracelet with 8 round diamonds .55 carats, valued at \$1695.00 and 1 yellow gold rope bracelet with 10 point diamonds with a Merrill Lynch bull charm, valued at \$595.00.

On 9/9/19 I made contact with Denise from Siga Services. Denise provided me Lella's name as Leyla Padilla and provided a phone number of 786-448-0513 and Maria De Cruz' phone number as 561-633-6601. Note; Leyla correct spelling in DAVID comes back as Leyla Socorro Padilla Acosta.

On 9/13/19 Maria De Cruz's name and phone number were entered into RAPID with negative results. Leyla's name was also entered into RAPID under both spellings and her phone number in which numerous hits came back to jewelry transactions at La Familia Pawn at 2304 \$ Military Trail, West Palm Beach, FL 33415 after the date of theft. I went to La Familia Pawn and met with assistant manager Jinad Saadeh. Saadeh presented me in person all the jewelry that was transacted by Leyla. I was able to locate the stolen yellow (gold) Merrill Lynch double rope with bull tag and diamond bracelet. Norma was shown a photo of the yellow (gold) Merrill Lynch double rope with bull tag and diamond bracelet and stated yes that is hers.

A pawn shop hold order form was completed for the Merrill Lynch bull tag. A transaction form (49957) was obtained from La Familia showing the transactions being made by Leyla on 8/20/19 at 5:22pm and Leyla placing her thumb print on the bottom right corner stating these Items are not stolen Items. A property receipt was completed for obtaining the transaction form.

On 9/19/19 I met with Chanelly Estrada at La Familia Pawn who is the employee who made the transaction with Leyla. A pawn shop affidavit form was completed and signed by Chanelly. Chanelly stated she remembers the transaction and stated she had a feeling it might of been stolen because you dont get a Merrill Lynch double rope with built ag and diamond bracelet when you've never worked there.

I also met with Jose Estrada (manager of La Familia Pawn) who stated he was also there that day and spoke with Leyla. Jose stated he also had a feeling it was stolen. Det. Gorfido, ID 24739, presented Jose with a photo lineup. Det. Gorfido presented Jose with a white folder with the words photo array/witness instructions written across the top which contained a photo lineup inside. Det. Advirige read the prepared photo line-up instructions to Jose as per PBSO General Order 456.00. After reading the instructions to

Jose, Jose initialed each instruction, signed and dated the folder. Jose then opened the folder to begin looking at the photo lineup.

Jose initialed and dated the photo in the number two position and closed the folder. The photo lineup was then ended. This concludes Det. Gorfido's involvement in this case. Note; the number two selection was a positive identification for Leyla Socorro Padilla Acosta. Video surveillance of Leyla performing the transaction was provided from La Familla and submitted into evidence.

On 10/22/19 I met With Denise Rodriguez (owner of Siga Services) and Leyla Socorro Padilia Acosta at 8056 Key West Lane in Boynton Beach Fi. Denise helped translate in Spanish for me. Post Miranda, Leyla stated she did not know anything about the jewelry then stated she wanted a lawyer. The interview was ended. Leyla was transported to District 6 to complete paperwork then transported to the Palm Beach County Jail Without Incident.

Based on the above investigation, I find probable cause to charge Leyla Socorro Padilia Acosta with 1 count of Grand Theft ≥\$300 <\$5,000 FSS: 812.014(2)(c)(1), 1 count of False verification of ownership ≥\$300 FSS: 539.001(8)(b)8b and 1 count of Dealing In Stolen Property FSS: 812.019(2).
