I was conducting patrol at 10th Ave N. and I95 in the incorporated City of Lake Worth Florida 33460, in marked PBSO vehicle # 70102. At 2034 hours, I saw a white Toyota Carolla, bearing Florida tag IFLW84 driving westbound on 10th Ave N., over the I95 ramp, with the rear license plate light out, violating FSS 316.221 (2). I conducted a traffic stop on the vehicle and we came to a final stop at 983 Barnett Dr.


As I approached the vehicle, I could smell the odor of marijuana coming from inside of the vehicle which had both the driver side and passenger side windows down. When I made contact with the driver, later identified through the Driver and Vehicle Information Database (DAVID) as Lianet Cabrera, she was advised the reason for the stop and asked for her documentation for the vehicle and her drivers license.

Ms. Cabrera started to look for her documents in her vehicle. When she opened up the center console of the vehicle she pulled out small clear plastic bag which contained a leafy green substance. Ms. Cabrera then spontaneously uttered that the contents of the bag contains marijuana.

Post Miranda Ms. Cabrera advised she has nothing else inside of the vehicle and we can search her and her vehicle. She advised she just bought the "weed" for twenty dollars and recently dropped her friend off and she was on her way home.

I field tested the marijuana, utilizing an issued Duquenois reagent test kit. Within fifteen seconds, the field test kit produced a purple hue, indicating a positive reaction for Tetrahydrocannabinol (THC), which is an active chemical in marijuana. The marijuana weighed 2.31 grams.

Based on my investigation, physical evidence and post Miranda statements, I found Ms. Cabrera to be in violation of FSS 893.13(6)(B), because he was knowingly in actual or constructive possession of 20 grams or less of a material, compound, mixture or preparation which contained cannabis, commonly known as marijuana, a controlled substance.
