PROBABLE CAUSE

On the above date and time, I responding to a crash scene at the location of 3925 Park Ln, Palm Springs Florida, the Palm Springs Police Department (PSPD) were investigating. When I arrived on scene, I observed a tan colored vehicle, in the eastbound travel lane on Park Ln facing an easterly direction, with heavy front end damage. I then observed a dark colored vehicle partially in the eastbound travel lane facing a westerly direction with heavy front end damage also. I then exited my patrol vehicle and spoke with the primary crash investigating officer on scene for PSPD. Officer Ferrer advised me that the responded to a crash in the area of Park Ln and Kirk Rd around 11:30 PM. Once on scene PSPD Officer Ferrer advised that he observed an injured male driver; later identified by his Florida Driver's License number as R160420941800 as Joel Rovira, inside the tan vehicle, and the driver of the dark colored vehicle; who was later identified by his Florida Driver's License number C-236-520-79-460-0 as LIBAN CASTRO ALVAREZ; who was standing outside of this vehicle pacing back and forth. Officer Ferrer then activated EMS personnel to the scene for medical evaluation on both driver. Mr. Rovira was transported to the hospital due to incapacitating injuries. Officer Ferrer then advised me while speaking to Mr. Alvarez about the crash events, Officer Ferrer detected an odor of an unknown alcoholic beverage coming from Mr. Alvarez's mouth and breath area. That is then PSPD requested Florida Highway Patrol (FHP) assistance for further Driving Under the Influence (DUI) investigation. I then became the primary DUI Trooper on scene. I the repositioned my patrol vehicle behind Mr. Alvarez's vehicle. After, I then began to speak with Mr. Alvarez. Mr. Alvarez advised that he spoke Spanish only. Officer Ferrer advised he would translate for me. While speaking to Mr. Alvarez, I detected an odor of unknown alcoholic beverage coming from Mr. Alvarez mouth and breath area. I then asked Mr. Alvarez on what happened leading up to the crash. Mr. Alvarez advised the he was driving westbound on Park Ln after getting pizza, when suddenly he felt an impact. Mr. Alvarez advised that's all he remembers. I asked Mr. Alvarez to point out the vehicle he was driving. I asked Mr. Alvarez did he consume and alcoholic beverages prior and or while driving. Mr. Alvarez advised that he had two-three beers tonight before driving. I further observed Mr. Alvarez to have red glassy eyes. I then advised Mr. Alvarez that PSPD Officers have completed their crash investigation and that I (FHP) am now conducting a DUI investigation. I then read Mr. Alvarez his Constitutional Warnings. After doing so, Mr. Alvarez advised that he understood his rights and would continue to speak with me throughout the investigation. I then asked Mr. Alvarez on what happened leading up to the crash. Mr. Alvarez advised the he was driving westbound on Park Ln after getting pizza, when suddenly he felt an impact. Mr. Alvarez advised that's all he remembers. I asked Mr. Alvarez to point out the vehicle he was driving. Mr. Alvarez then pointed to the dark colored vehicle facing in a westerly direction on Park Ln. I asked Mr. Alvarez did he consume and alcoholic beverages prior and or while driving. Mr. Alvarez advised that he had two-three beers tonight before driving. When asked, Mr. Alvarez agreed to submit to a series of field sobriety exercises. Officer Ferrer continued to translate to Mr. Alvarez.

Horizontal Gaze Nystagmus exercise

Prior to beginning the exercises it was determined Mr. Alvarez was not wearing contacts. Mr. Alvarez eyes were checked and his eyes displayed equal tracking and his pupils were equal sizes. Mr. Alvarez was instructed to following the stimulus with his eyes only, keeping his head still. After stating he understood the instructions Mr. Alvarez attempted this exercise.

The results of this exercise displayed 6 of the 6 possible clues.

- A lack of Smooth Pursuit in his left eye.
 - A lack of Smooth Pursuit in his right eye.
 - A distinct and sustained nystagmus in the left eye at maximum deviation.
 - A distinct and sustained nystagmus in the right eye at maximum deviation.
 - An onset of nystagmus in the left eye prior to 45 degrees.
 - An onset of nystagmus in the right eye prior to 45 degrees.
 - The exercise further revealed the presence of vertical nystagmus. Vertical nystagmus is an indicator of high doses of alcohol, other central nervous system (CNS) depressants or inhalants, and the consumption of the drug phencyclidine (PCP).
- While performing the Horizontal Gaze Nystagmus exercise, it was observed that Mr. Alvarez:
- Had difficulty following and responding to instructions.
 - Moved his head from side to side during the exercise.
 - Swayed while standing.
 - The instructions for the exercise had to be repeated before Mr. Alvarez would respond

Walk and Turn exercise

Prior to attempting this exercise, Mr. Alvarez indicated he did not have any medical problems that would have prevented him from performing the exercise. Mr. Alvarez was instructed to put his left foot on the yellow line and his right foot in front of it with his right heel touching the toe of his left foot. He was instructed to stand in this manner with his hands to his sides until the exercise instructions were completed and the exercise demonstrated. Mr. Alvarez was instructed not to begin the exercise until told to start. He was instructed to take nine steps along the yellow line in a heel-to-toe manner. After the ninth step he was to stop and turn around keeping his lead foot on the ground, taking several small steps with the other foot to turn around. After turning around he was to take nine steps in a heel-to-toe manner back along the imaginary line, in the direction he had come from. Mr. Alvarez was further instructed to watch his feet at all times while walking, keep his arms down to his side, and to count his steps out loud. After the exercise was demonstrated Mr. Alvarez stated he understood the instructions and was instructed to begin the exercise.

- After attempting the Walk and Turn exercise Mr. Alvarez displayed 5 of 8 possible clues.

Walk and Turn exercise observations:

- On the first set of steps Mr. Alvarez failed to walk in a heel-to-toe manner on 2,4,8,9 steps, - On the second set of steps Mr. Alvarez failed to walk in a heel-to-toe manner on 5,6, steps, - Was unable to stand in a heel-to-toe manner while the instructions to the exercise were given.
- Raised arms for balance during the exercise.
- Turned incorrectly.
- Started the exercise before instructed to.

One Leg Stand exercise

Prior to attempting this exercise, Mr. Alvarez indicated he did not have any medical problems that would have prevented him from performing the exercise. Mr. Alvarez was instructed to stand with his heels together and hands down to his sides while the instructions were given and during the exercise. Mr. Alvarez was instructed not to begin the exercise until he was instructed to start, and after the exercise had been demonstrated. When instructed to start, he was to raise the foot of his choice off the ground approximately 6 inches. While his leg was raised he was to keep his leg straight, watch his raised foot, and to count out loud by thousands (one thousand one, one thousand two, one thousand three...) and to continue the exercise until told to stop (30 seconds). After this exercise was demonstrated and indicating he understood the instructions Mr. Alvarez attempted this exercise.

When Mr. Alvarez attempted this exercise he raised his right foot. Then switched to his left foot

The result of this exercise displayed 4 of the 4 possible clues.

During this exercise Mr. Alvarez:

- Swayed during the exercise.
- Used arms for balance.
- Hopped during the exercise
- Put his foot down (3 time(s) during the exercise).

Additionally, during the One Leg Stand exercise, Mr. Alvarez was observed to:

- End the exercise before he was told to put his foot down. (He was to keep his leg raised for 30 seconds). Ending the exercise at the count of 15. Then raised his left foot for the remainder of the exercise
- Fail to watch his raised foot during the exercise as instructed.
- Fail to keep his raised leg straight.

After I completed the Standardize Field Sobriety Exercise observations on Mr. Alvarez, I then placed Mr. Alvarez under arrest for suspected DUI of alcohol. I then placed searched Mr. Alvarez's person for weapons and or contraband. Subsequent search of Mr. Alvarez's property led to the discovery of a small clear baggie containing a white powdered substance contained inside. Mr. Alvarez advised that the powdered substance was cocaine. Due to officer safety reason, the white powdered substance was not field tested. I then placed Mr. Alvarez in the rear of my patrol vehicle, and secured him in. Shortly after, I departed the scene enroute to the Palm Beach County Jail. Upon arrival at the jail, I escorted Mr. Alvarez to the BAT center. There, I conducted a 20 minute observation period of Mr. Alvarez. Once the 20 minutes were up, I escorted Mr. Alvarez into the BAT room. Once there, I requested Mr. Alvarez to submit to a lawful test of his breath for the purpose of determining its alcohol content. Mr. Alvarez followed along in Spanish. After reading the Spanish version, Mr. Alvarez agreed to submit at 1:12AM. Mr. Alvarez provided an adequate breath sample of .123 at 1:17AM and another breath sample of .120 at 1:20AM. No Q&A was conducted, I then transported Mr. Alvarez to booking into the Palm Beach County Jail. Shortly after, Mr. Alvarez was booked into the Palm Beach County jail on 316.193.1 and 893.13.6a Florida Statute Misdemeanor DUI. After, the powdered substance was submitted into evidence at the Lantana Substation. All events occurred in Palm Beach County.

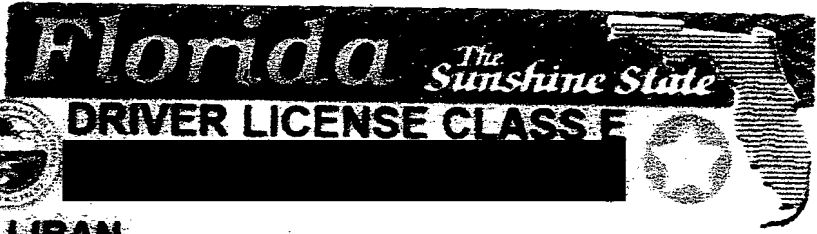
