**PERSONAL CONTACT**

**NARRATIVE:**

On 2/11/17 at approximately 0520 hrs I responded to 137 Vanessa St. Palm Springs Palm Beach County, Florida in reference to a domestic battery. While enroute to the call I was traveling east bound on 2<sup>nd</sup> Ave N I observed a white van, later discovered to be driven by the victim, flashing its headlights. I didn't know that at the time so I continued to the address above. Upon arrival I made contact with the female identified as Lina Cano. While speaking to Cano I smelled an odor of an unknown alcoholic beverage coming from her breath. Cano stated she was at home and she began to argue with her husband, Alberto Martinez, over lying to her when she was pregnant with there son. Cano stated Martinez tried to leave the residence in his van and she tried to stop him. Cano stated Martinez pushed her into the bushes outside during the argument. I did not observe any signs of injury relating to a fall. While I was speaking to Cano, Martinez arrived back at the residence. I made contact with Martinez outside. Martinez stated Cano and her cousin went out drinking and he told her before she left that he had to go to work at 5 and not to be out late. Martinez stated Cano came back to the house at approximately 0500 smelling like alcohol. Martinez stated he yelled at Cano telling her "if that was a good time for a mother to come home to take care of her 6 month old son". Martinez stated Cano then grabbed his phone during the argument and smashed it on the floor. Martinez stated he then took the laptop and broke it on the ground. Martinez stated Cano then began hitting him. Martinez stated he then went out to his van to leave the residence and Cano followed him continuing to hit him. Martinez stated Cano then took his keys and jumped into the van. Martinez stated he removed Cano from the van. Martinez stated he drove away and saw me coming to the residence and tried to flag me down. While speaking to Martinez I observed redness on the side of his left eye, a scratch on the left side of her neck, and scratches on his lower torso area. Photos were taken of Martinez's injuries. A Domestic Rights and Remedies packet was issued to Martinez for his needs. Due to my observations Cano was placed under arrest for Domestic Battery. The cuffs were placed behind her back, double locked, and checked for tightness. Cano was transported to PSPD for further paperwork to be conducted and then transported to Palm Beach County jail.

Cano stated Martinez was being very aggressive and pushed her to the ground outside of the house while they were arguing and she tried to keep him from leaving.




