Personal Contact

Driving Pattern

Actual physical control (physical evidence putting the driver behind the wheel)

I responded to 1901 Okeechobee Blvd. in reference to a traffic crash involving a possible impaired driver. Upon arrival I made contact with Serxia Yang who was driving the vehicle that was struck. Yang stated he was traveling West on Okeechobee Blvd. stopped at the traffic light for the I-95 South exit ramp. Yang stated while stopped he looked in his rear view and saw a red BMW approaching him quickly. Yang stated the vehicle then struck him. Yang stated he made contact with the driver and he described her as being "off." He stated at one point the driver asked him where her registration was. I spoke to D/S Brad Rightler #6389 who was on scene. He stated he could smell the odor of an unknown alcoholic beverage emitting from the driver and she had trouble maintaining her balance. The driver who was the sole occupant of the vehicle was identified as Linda Woosley by her FL registration. This was confirmed through her picture in DAVID.

Observation of Driver

Upon making contact with the driver she was sitting in the driver seat of the vehicle. I could immediately smell the strong and distinct odor of an unknown alcoholic beverage emitting from her person. The odor became stronger off of her breath as she spoke to me. The drivers eyes were bloodshot and glassy. Her speech was thick and slurred. When she got out of the vehicle the driver had difficulty maintaining balance while walking.

Drivers Statements:

I advised the driver the crash investigation was complete and I was now conducting a DUI investigation. Post Miranda the driver stated she was coming from West Palm Beach then stated home. I asked her where she was going and she stated here. I asked her if it was here to look at furniture and she stated yes. I asked the driver how much she had to drink and she stated not much. I asked her how many that was and she stated a drink, maybe a drink. I asked her what it was and she stated wine. I asked her how long ago she had the glass of wine and she stated a long time ago, 8 hours maybe. The driver consented to roadside tasks.

While performing this exercise there I observed an immediate angle of onset. VGN was not present. The driver was observed swaying heavily from front to back. The driver was observed moving her head which I reminded her several times not to move and had her reposition her hands to keep her head from moving.

Walk and Turn Task

I instructed the driver to stand with her right foot in front of her left with her hands down by her side. The driver attempted to do this several times and had difficulty maintaining balance. The driver was not able to get into this position and I advised the driver to stand with her feet together on the line. After giving the instructions the driver stated she understood the instructions. The driver stated she could not do the exercise. I asked why and she continued to state she just couldn't. The driver agreed to do the exercise starting before told to do so. I stopped the driver and told her to wait till I told her to begin. The driver took 5 steps missing heel to toe and stepping off of the line on all steps. The driver then stated she could not do the exercise.

One Leg Stand

I had the driver stand with her feet together and hands down at her side. I explained and demonstrated the exercise and the driver stated she understood the instructions. When told to begin the driver lifted her right foot off of the ground. The driver set her foot down on the ground 3 times and never raised it back up. The driver was observed lifting her arms more than 6" away from her body. The driver stated this is crazy then stated, "I must be crazy."

Finger To Nose

I had the driver stand with her feet together and index fingers pointed straight out. I explained and demonstrated the exercise to the driver and she stated she understood. I instructed the driver to tilt her head back and close her eyes. On the first left the driver lost balance taking a step back then brought her left finger to the tip of her nose then to side of her left nostril. On the first right the driver brought her right finger to the right side of her nose. On the second left the driver brought her left finger to the bridge of her nose then moved it to her left eye. On the third right the driver brought her right finger up between her eyes. On the third left the driver brought her left finger to the tip of her nose then to her left eye. I had to remind the driver to bring her arm back down on all movements except for the third left. The driver was observed swaying from front to back.

Romberg Alphabet

The driver stated her highest level of education was graduating from high school. The driver stated she did know the alphabet and could recite it. The driver recited the alphabet from A to W, then S, Y, Z. The driver was observed swaying from front to back.
