 On the **21** day of **November**, **2017** at **14:59** (Specifically include facts constituting cause for arrest.)

The following incident was captured on a mobile video recorder. On Tuesday, November 21, 2017 at approximately 1437hrs, I was dispatched to the area of 2390 North Federal Highway, Boca Raton (CVS). The witness told dispatch that a white female, later identified through her Florida driver's license as Linda Serabian, was intoxicated inside of CVS and possibly trying to shoplift an alcoholic beverage.

Officer Clinard (ID#780) met with the witness, Annette Hauser at the above location. Annette told Officer Clinard the following: Annette stated that she was notified by her cashier when Linda approached the front counter. Annette stated that Linda appeared to be very intoxicated and smelled like alcohol. Annette observed an unpaid 4-pack of Sutter Home Pinot Grigio wine valued at \$7.49 inside of Linda's purse. She told Linda to remove the wine and to leave the store in which Linda complied. When Linda left, Annette followed her outside and watched her enter a black Mercedes bearing FL Tag "800PCP". Linda then drove northbound on North Federal Highway from NE 24th Street. Annette completed a written statement that was submitted into evidence.

Over the radio, Officer Glass (ID#681) advised that he had located the suspect's vehicle. Officer Glass told me the following: he located a 2013 black Mercedes C300 bearing FL Tag "800PCP". The vehicle was blocking the intersection of North Federal Highway/NE 32nd Street. He approached the vehicle and made contact with Linda Serabian who was the driver and sole occupant. Linda told Officer Glass that her vehicle broke down. Officer Glass detected a strong odor of an unknown alcoholic beverage emanating from Linda's breath. He stated when Linda exited the vehicle, she began walking towards traffic. It must be noted that there was moderate vehicle traffic in the area during that time. For safety reasons, Linda was detained by Officer Glass and secured in the rear of his marked patrol vehicle until I could arrive.

I made contact with Linda who was still seated in the rear of the patrol vehicle. I

could smell a very strong odor of alcohol coming from her breath and person. I could distinguish this odor through my training and experience. Her eyes were glassy and speech was both slow and slurred. These are all typical symptoms of being under the influence of alcohol. When Linda exited the vehicle, she had a difficult time maintaining her balance and kept swaying from side to side. I escorted Linda to the front of my patrol car in order to speak with her. Linda attempted to walk away from me as I spoke. She was told to stop and that she was not free to leave. When asked how much she had to drink, Linda said, "A lot". I asked her if she thought it was a good idea for her to be driving and she said no. Linda later said she was drinking white wine while at her house. She then attempted to walk away from me for a second time and again had to be stopped. Once more, I explained to Linda that she was not free to leave and that I had reason to believe that she should not be driving. Linda attempted to walk away a third time and was given one last chance. I told her that I was going to give her an opportunity to dispel my alarm that she was operating a motor vehicle while under the influence of alcohol. Linda attempted to walk away a fourth time. At this point, I told her she was under arrest and took her into custody for DUI.

Linda was unable to dispel my alarm and refused to fully cooperate while on scene. Officer Greenberg conducted the Intoxilyer 8000 testing at the Boca Raton Police Department. I asked Linda if she would provide breath samples and she did. Cynthia provided two samples of .273 and .270. On camera, I read Linda her constitutional warnings. Linda signed the DUI Influence Report advising that she understood her rights. Once again, Linda admitted to drinking a lot of white wine today while at home. She began drinking this morning and continued to consume wine up until Officer Glass made contact with her. I located a 4-pack of Sutter Home Pinot Grigio white wine (13%) in her purse. One of the bottles were open and half empty.

Based on the above information, Linda Serabian is being charged per F.S.S. 316.193(1) for DUI. Linda was transported to Boca Raton Police Department then taken to the Palm Beach County Jail. Linda's vehicle was impounded by Emerald Towing.


