DUI ALCOHOL OR DRUGS

PROBABLE CAUSE

Defendant was driving northbound on SR9 / I-95 from 45th ST in the left center lane and passed my marked patrol car as well as other traffic at an estimated speed of 80 mph. My partner, R/T Petti was driving, and accelerated to overtake the defendant. As we closed on defendant, she moved to the left lane, back to the left center lane then to the center lane without using her turn indicator. She was clocked by moving radar at 80-81 mph, then moved to the right center lane, again without signal. We activated our emergency lights. Defendant continued without slowing or attempting to change lanes for approximately 3/4 mile, then moved to the right exit lane to Northlake BV. She then slowed but did not stop. I activated the siren and defendant stopped just before the exit to SR-850 / Northlake BV.

R/T Petti approached the passenger side of the car, I stood near the rear of the car, close enough to hear, but I could not clearly see defendant. I smelled a faint sweet odor, like chewing gum, and a faint odor of an alcoholic beverage. We issued defendant a citation for unlawful speed, during which time we discussed whether she (Petti) suspected alcohol. When we returned to the car, I addressed defendant. I could see a tin of Altoids in the center console, and I could more clearly smell the two distinct odors of her gum and an unknown alcoholic beverage. I asked defendant to verify where she had been, she said at a business meeting at a restaurant in Delray Beach. I asked how much she'd had to drink and she said nothing. Her eyes were bloodshot and glassy, and she mumbled and spoke very softly and kept turning her face away from me as she spoke. I asked defendant to come out of the car, and she complied.

We stood at the rear of defendant's car on the shoulder. I asked again about her trip and the meeting, and each time defendant spoke she turned her face away from me. I asked her to spit her gum out, which she did. I knew from checking her DL that defendant had a prior refusal. We discussed this, and she said the DUI was dropped, and I explained that the refusal was still on her record. Defendant's responses during our conversation were evasive, and she continued to turn away from me as she spoke. In spite of this, I was able to clearly smell the odor of an alcoholic beverage when she spoke.

Defendant agreed to perform FSTs. Prior to beginning, I asked her if she had any medical issues or took any medication or drugs. She said she took half of an Ambien (sleep aid) at approximately 2:30 or 3:00 am. FSTs were performed on the shoulder as follows:

HGN: slight orbital sway when she stood, lack of smooth pursuit in both eyes, onset prior to 45% in both eyes, distinct at maximum deviation in both eyes.

W&T: Kept stopping me during the instruction phase because she felt the shoulder was too sloped. After moving twice, she finally began to comply with instructions. Stepped off to the left during instructions, and started to walk. Only the first step was heel-toe, all others at least 3-4", turned by pivoting on both feet, then stopped and said out loud "continue" (not as a question). Lost balance on step 3 back, crossed her feet and stepped to left and said "oops".

OLS: raised right leg, knee bent until Petti & I both told her to straighten her leg. Lost balance and put foot down for 2 seconds at 27 seconds.

We arrested defendant for DUI, R/T Petti handcuffed her and secured her in my car. As Petti inventoried the car, defendant asked me numerous questions about where she was going, how could she call an Uber and a bondsman, where was she going. I answered the questions several times.

We transported defendant to the PBSO BAT. We arrived, catalogued her property and conducted a 20 minute observation period. We entered the test room with DUI Tech S. Palmer. Defendant initially said she would not take a breath test, that her lawyer told her not to. I read Implied Consent on video, and after numerous questions (on video), she verbally agreed to take the test. As the instrument went through the startup process, defendant continued to ask questions. As Palmer began to explain the test, defendant said she was not going to take the test. I verified that she understood Implied Consent, and she refused.

A review of defendant's DL in DAVID indicated a prior refusal to submit to a lawful test on 03/24/2004.




