POSSESSO MARIJUANA OVER 20 GRAMS HASH OIL

PROBABLE CAUSE

On Friday July 14th 2017 at 1258 hrs., I (Ofc. Loney 1213) observed a dark color sedan bearing FL tag WA13M disobey a traffic control device (stop sign) at the intersection of Tequesta Dr and Country Club Dr, within the confines of the Village Of Tequesta. Upon making contact with the driver, later identified as Lindsay Reimer, I smelled a strong odor of Marijuana coming from inside of the vehicle. When asking Reimer if there was anything in the vehicle, Reimer stated there was not.

At this time, Reimer was advised to step out of the vehicle and proceed to the bumper of my patrol vehicle parked behind. While Reimer walked toward my patrol vehicle, Reimer stated she had Marijuana inside of her vehicle.

Ofc. Robinson 1203 performed a search of this vehicle and recovered a small sealed baggie, with a wax item wrapped inside of it in under the papers on the driver's seat of this vehicle. NARK Field test kit NAR10008 tested positive for THC. Net weight of hash oil weighed 2.4 g (grams).

I believe there is Probable Cause to charge Reimer with Possession of Marijuana > 20g (FSS 893.13(6)(a))
