Lantana Communications advised that a concerned citizen contacted the Lantana Police Department and advised the following:</p> <p>An unknown white female, last observed wearing a black sports bra and black shorts, was observed walking in and out of traffic in a dangerous manner and appeared to be under the influence of either alcohol or an unknown controlled substance. Upon arrival, I made contact with w/f Lindsey Coughenour (09-23-1992), who closely matched the above stated physical description, in the businesses parking lot.</p> <p>I observed Coughenour carrying a large glass bottle of Smirnoff triple distilled vodka in her right hand. Coughenour was slightly disoriented, her speech was slurred, her eyes were glossy and red in color, and she was verbally aggressive. Upon requesting for Coughenour to produce identification, she continued to behave in an uncooperative manner and made evasive maneuvers toward Officer Frommer, ID#859, and I. Coughenour was directed multiple times that she needs to remain seated and cooperate with officers while we conduct an investigation. At this point, Coughenour stated the following phrase, "Fuck you dicks, I don't have to listen to shit!" Again, Coughenour was explained as to why she was being detained and that she is not free to leave as she was heavily intoxicated.</p> <p>Immediately following, Coughenour stated, "Fuck you, I ain't doing what you motherfucking assholes want." Moments later, Coughenour became physically combative and lunged at Officer Frommer and I. Due to officer safety concerns, Coughenour was escorted to the wall where she was safely placed in custody.</p> <p>Coughenour was placed in handcuffs behind her back, the handcuffs were checked for</p>

proper spacing, tightness, and were double locked. It should be noted that while attempting to handcuff Coughenour, she repeatedly pulled away from Officer Frommer and I, failed to abide by our lawful verbal commands, and kept physically resisting until she was successfully placed in handcuffs.

On scene, I made contact with the Eyecare Professional's practice administrator, w/f Sherri Fullilove (09-13-1962), who advised the following:

Coughenour barged into the businesses front door, was observed holding a 750ml bottle of vodka, and was screaming at customers to use the restroom. Fullilove informed Coughenour that she needs to stop causing a disturbance and that she needs to leave the premises as she was drunk. Coughenour then mumbled profanity toward the staff members, continued to act as a nuisance for a few minutes, and exited the business once she observed the presence of law enforcement. Fullilove completed a sworn written statement in regards to the incident. Coughenour was then transported to the Lantana Police Department for further processing.

Based on the aforementioned statements, probable cause exists to charge Coughenour with disorderly intoxication (Pursuant to F.S.S. 856.011) and resisting/obstructing arrest without violence (Pursuant to F.S.S. 843.02). Coughenour was subsequently lodged in the Palm Beach County jail and turned over to the Palm Beach County Sheriff's Office.

At this time, there is no further information to report.
