On 9/29/19 I responded to the area of 3797 S. Military Trail in reference to a domestic dispute. Upon arrival, I observed a W/F later identified as Lindsey Vanhorn sitting in front of a business on the ground. In front of the aforementioned address, I observed a charcoal color Cheverolet (FL Tag KPXK26) parked in the middle of the parking lot with broken glass under the passenger window. This glass was later discovered to be from light bulbs. Walking towards the vehicle from the southern side of the parking lot, I observed a W/M, later identified as Chase Ahlborg.

When I first arrived, Ahlborg was walking towards me and I could clearly see that his black shirt was torn in the middle, exposing his entire chest. I could also see blood on the right side of his neck and scratches on his abdomen. It was later told to me that the blood on his neck was due to being scratched.

I spoke to Ahlborg first while another Deputy spoke with Vanhorn. Ahlborg advised me that he and his girlfriend were driving south on Military Trail when he had told her that her attitude lately had been "shitty," and he wanted to call her mother about it. Ahlborg said that after numerous arguments with her in the past, this statement was an example of the little things that made her upset. After stating this to Vanhorn, she became irate. Vanhorn began yelling at him and grabbed the steering wheel of the vehicle. Ahlborg told me that he was able to maintain control of the car and managed to stop it in the parking lot at 3797 S. Military Tr.

Once the vehicle stopped, Ahlborg started to be attacked by Vanhorn from her scratching at him. Ahlborg said that he sustained the scratches to his neck and abdomen at this time and Vanhorn had also torn his shirt. Ahlborg said he exited the vehicle and attempted to get Vanhorn out but she refused to leave. Vanhorn grabbed one of the light bulbs from inside the car and broke it on the ground. It was during this time that Vanhorn shut the door to the vehicle and decided to call 911. Ahlborg said he walked away from the car and called as well. While waiting for officers to respond, Ahlborg began setting off the car alarm by using the key less remote in attempt to get Vanhorn to exit.

The part of the incident where Ahlborg walked away from the car and then set off the cars alarm was witnessed by business owner George Bradey (1/12/53), but Bradey advised that nothing involving the physical altercation was observed by him.

After speaking with Ahlborg, I proceeded to ask Vanhorn what occurred. Vanhorn stated that as they were driving south on Military Trail, Ahlborg was telling her that he wanted to hit a "lick", which meant that he wanted to rob someone. Vanhorn said that he said this because he had no money and could not afford any drugs. Vanhorn told Ahlborg that she wanted nothing to do with that and to drive her home. Ahlborg refused to drive her home but offered to order an Uber. Vanhorn refused and it was at that time that Ahlborg parked the car (in the middle of the parking lot), exited and proceeded to open the passenger

door to pull Vanhorn out. Vanhorn told me that Ahlborg had grabbed her by the throat and hand causing a bruise and scratch. When Ahlborg could not remove her from the vehicle, Vanhorn shut the door and proceeded to call 911. After being told this, I observed a small amount of redness on the right side of Vanhorns neck/collar and a scratch on her right palm. I was unable to determine how recent the scratch could have been made but may have just occurred.

After speaking to both parties several times, I asked Vanhorn how Ahlborg received the all the scratches. Vanhorn replied that they were from sex. It appeared Vanhorn did not understand that I was asking about the fresh scratches which caused him to bleed, but again she stated that it was from them having sex. When I asked her again why is Ahlborg scratched on the neck and is now bleeding, Vanhorn responded that she defended herself from when he grabbed her by the neck to remove her from the vehicle.

Due to the conflicting statements from both parties and the fact that Vanhorn attempted to explain the scratches to me at one point as occurring from a separate incident, I placed her under arrest for domestic battery due to the couple dating for three years and residing in the same residence.

Photographs were taken of Ahlborg and Vanhorn and uploaded to the PBSO Domestic Violence page by D/S Gonzalez. Ahlborg completed a sworn statement and provided with all case information and a domestic violence pamphlet. Vanhorn was handcuffed, double locked and transported to District 16 for processing and subsequently the Palm Beach County Jail.
