On Thursday, April 19th, 2018, at approximately 1437 hours, I was dispatched to 1310 W Lantana Rd (Motel 6), in reference to a suspicious incident. Which was later to be determined to be a trespass after warning.


Upon arrival I made contact with, w/f Lindsey Coughenour (09/23/1992), who appeared to be heavily intoxicated from an unknown alcoholic beverage. Ms. Coughenour, was slurring her words and could not formulate appropriate sentences.

Ms. Coughenour, stated that her boyfriend, w/m Cameron Howard (03/27/1997), hit her in the eye. It should be noted that Ms. Coughenour did have a bruise above her right eye. However, Mr. Howard, stated the bruise was from a previous incident which was found to have occurred outside of Lantana Police Department's jurisdiction.

Ms. Coughenour, was advised to gather her belongings and exit the property. However, Ms. Coughenour, did not comply with my commands. I then again gave Ms. Coughenour an order to exit the property. She continued to ignore my orders. Finally, Ms. Coughenour, was warned that she would be arrested if she did not leave the premises. Ms. Coughenour still did not comply.

I then attempted to control Ms. Coughenour by her wrists when she began to passively resist myself and Officer Waldkoetter (ID# 865). Ms. Coughenour was escorted to the ground by myself and Officer Waldkoetter (ID# 865), while giving verbal commands to "stop resisting". Once on the ground, Ms. Coughenour, was continuing to passively resist Officers by keeping her arms tense and not placing them behind her back when ordered to do so.

Ms. Coughenour, was eventually, placed into handcuffs (double locked and checked for tightness), and transported to Lantana Police Department in my marked "Lantana Police"

<p>vehicle, for processing. While at headquarters, Ms. Coughenour, requested medical assistance for shortness of breathe. Therefore, PBCFR, responded (RUN# 18043373). Ms. Coughenour was subsequently, cleared by FD at Lantana Police headquarters.</p> <p>Ms. Coughenour, was found to have a trespass warning from Motel 6 that was issued on 04/05/2017. It should be noted that Ms. Coughenour was also arrested on 04/04/2017 for disorderly intoxication, as well as, resisting arrest without violence, see Lantana case number 17-000845 for additional details. The outcome of the above listed arrest was a Diversion Program, see court case number 2017MM004232ASB for additional details.</p> <p>The General Manager of Motel 6, Andre Huggins (07/01/1968), agreed to complete a sworn statement. Mr. Huggins stated that the female (Ms. Coughenour), called the front desk stating someone took her phone. Mr. Huggins, then went to the room in order to assist Ms. Coughenour. Once at the room, Mr. Huggins, observed Ms. Coughenour and Mr. Howard in a verbal altercation. Ms. Coughenour was "...all over the male that was in the room.". Mr. Huggins stated the male (Mr. Howard), was attempting to leave, Ms. Coughenour threw a glass bottle at him, stating "it was his", according to Mr. Huggins. The glass bottle was found to be Vodka.</p> <p>It should be noted that the offender, Ms. Coughenour, stated that her mom is going to have "our jobs" because she works for a Chief of police in New Jersey. While Ms. Coughenour, was in the Lantana Police Department holding cell she began to become violent, again. Therefore, Ms. Coughenour, had to be placed back into handcuffs (double locked and checked for tightness). Ms. Coughenour, was still violent, by kicking the holding cell door, repeatedly. As well as, spitting on the holding cell door window.</p> <p>Ms. Coughenour stated that Lantana Officers took her ring, as well as, "sexually assaulted" her. It should be noted that Ms. Coughenour was not wearing a ring and no Officer, whatsoever, touched her sexually.</p> <p>Once processed, Ms. Coughenour, was transported to Palm Beach County Jail, where she was lodged. I completed a use of control form for escorting Ms. Coughenour to the ground. All of Ms. Coughenour's belongings were turned over to Mr. Howard.</p> <p>This case is closed.</p>
