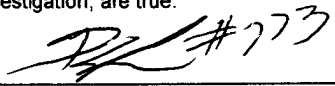

	Upon arrival, I observed Lisa Garcia and her adult son, Alec Mikailian, sitting in the lobby. I first spoke to Garcia who advised that she was in her hotel room when she got into an argument with Mikailian about his drug use. Garcia stated that Mikailian stood in front of her in an aggressive manner, which made her hit Mikailian several times on the arm (she did not remember which arm). Garcia advised that Mikailian made no threats towards her; however, she was just frustrated with him so she hit him. They both walked downstairs to the lobby and Garcia told the front desk clerk to call 9-1-1. I did not observe any injuries to Garcia and she never claimed to have any. I then spoke to Mikailian who confirmed that he got into a verbal argument with Garcia in their hotel room about his past drug use. Mikailian mentioned that during the argument, Garcia hit him several times on the arm (unknown which arm) and the upper body area. I observed no injuries to Mikailian's upper body or arm area. Due to both Garcia and Mikailian having similar accounts of the incident, I developed probable cause to arrest Garcia for simple battery (domestic) pursuant F.S.S. 784.03. Garcia was transported to Boca Raton Police Departments temporary holding facility for processing then to the Palm Beach County Jail.
