

On 05/02/2018 at approximately 2114 hours, I responded to the area of S A1A and Ocean Way in the Town of Jupiter, Palm Beach County, FL in reference to a careless driver. At the time, I was driving a fully-marked Jupiter Police Department patrol vehicle (vehicle 1425), I was wearing a JPD issued uniform clearly identifying myself as a Jupiter Police Officer, and I was wearing my department-issued Axon body camera.

Prior to my arrival, the caller advised that a gray Honda Civic was traveling southbound, swerving, and struck the median causing a tire to pop. The caller further advised that the vehicle was traveling southbound in the northbound lanes of travel on S US Highway 1.

Officer Zeitz, the first officer on scene, located the vehicle (gray 2011 Honda Civic bearing PA tag # HXZ3867) near the intersection of S US Highway 1 and Ocean Way. Officer Zeitz advised over the police radio that the vehicle was traveling southbound in the northbound lanes of S US Highway 1. She further advised via the police radio that the vehicle was not stopping for her. As Officer Zeitz made this transmission, I could hear her emergency siren in the background of the transmission. Officer Zeitz also advised that one of the vehicle's tires was flat.

I activated my overhead emergency lights and siren and began responding to the area of S US Highway 1. While enroute, officers behind the vehicle advised it had stopped between the intersections of Bluffs Blvd and Marcinski Rd. I immediately turned off my emergency overhead lights and siren and arrived at the scene shortly after.

Upon arrival, Officer Zeitz advised me that she was traveling southbound in the northbound lanes of S US Highway 1, behind the vehicle with her overhead emergency lights and siren activated, from just south of the intersection of S US Highway 1 and Ocean Way to the location the vehicle was stopped (just south of Bluffs Blvd). Zeitz advised the vehicle did not yield for the emergency vehicle behind it and did not re-enter the appropriate lanes of travel until the intersection at Bluffs Blvd (see supplement from Officer Zeitz).

I made contact with the driver and identified her by her valid Pennsylvania driver license to be Lisa Pilotti (w/f; 08/04/1962). Pilotti was initially standing out of her vehicle and using the driver side of her vehicle for balance. Pilotti walked back to her vehicle, despite officers advising her not to enter her vehicle. Pilotti sat back in the driver seat of her vehicle and appeared to be extremely unsteady on her feet, using her vehicle to steady herself as she walked back to the driver door.

Pilotti appeared to lose her balance into the seat, as she appeared to have no strength in her knees and flopped into the seat. I spoke to Pilotti for several minutes at the driver door of her vehicle. I noted that Pilotti had extremely slurred speech and I detected the strong odor of an unknown alcoholic beverage coming from her person and inside the vehicle.


Pilotti could not advise where she was coming from, did not know why she was being stopped, and stated that she was attempting to drive to the "Beach House" but could not advise where that was. She also stated she was down in Florida for alcohol treatment. Pilotti advised she consumed approximately 4 drinks prior to driving her vehicle, in her Hampton Inn hotel room. While speaking with Pilotti, I observed her fumbling with her phone, at one point holding it in her hands upside down for several seconds and tried using it before realizing that the phone was upside down. Pilotti could not recall the time without using a watch to determine the time.

When confronted about a flat front driver side tire, Pilotti advised she heard the tire pop and she had been driving on the tire for 15 minutes, trying to pull over.

I asked Pilotti to step out of the vehicle and walk to the front of my patrol vehicle, which I repositioned in the outside southbound lane of S US Highway 1, slightly in front of Pilotti's car. When Pilotti attempted to exit her vehicle, she attempted to exit her vehicle but immediately lost her balance, to the rear and fell backwards into the driver seat of her vehicle. Pilotti exited the vehicle on her second try and used the open driver door to balance herself.

While Pilotti was walking the approximate 10 foot distance from the driver door of her car to the rear of my patrol vehicle, she stumbled several times and used the entire passenger side of my patrol vehicle to keep herself balanced while walking to the front of my car.

Due to my observations of Pilotti, I determined that she was too intoxicated to complete roadside tasks without risking possible injury to her and I placed her under arrest. I

placed handcuffs on her wrists which were checked for proper spacing and double-locked to prevent tightening.

Officer Zeitz conducted a search incident to arrest of Pilotti's person and I placed her in the rear passenger seat of my patrol vehicle. Upon a search incident to arrest of Pilotti's vehicle, I located an open travel-sized container of wine in the driver door with a small amount of liquid in the bottom.


After briefly searching Pilotti's vehicle, I transported Pilotti to the Palm Beach County Breath Alcohol Testing Facility where I conducted a 20 minute observation period to ensure she did not ingest or regurgitate anything orally. At the conclusion of the observation period, I requested Pilotti submit to an approved test of her breath for the purpose of determining the alcohol content. Pilotti asked what would happen if she refused and I read her Implied Consent from a prepared text. After reading Implied Consent, Pilotti submitted to a breath test.

Pilotti provided two adequate breath samples of .241 and .240, both over the legal limit of .08. I attempted to read Pilotti her Miranda Warnings from a prepared text but she began talking over me and became uncooperative and I did not conduct a post-arrest interrogation.

I placed Pilotti in a holding cell while I completed the arrest paperwork. While in the holding cell, Pilotti was screaming and extremely loud for approximately one hour while the paperwork was being completed. Pilotti eventually calmed down and I booked her into the Palm Beach County Jail without incident.

I believe Probable Cause exists to charge Lisa Pilotti with DUI (Enhanced) because she did drive a vehicle, while under the influence of alcoholic beverages, while having a breath alcohol level of .08 or more grams of alcohol per 210 liters of breath and during the course of driving a vehicle while under the influence of alcoholic beverages, did have a breath alcohol level of .15 or more grams of alcohol per 210 liters of breath, contrary to Florida Statute 316.193(1) and (4).

I believe Probable Cause exists to charge Lisa Pilotti with Fleeing or Attempting to Elude Marked Police Car because she did willfully flee or attempt to elude a law enforcement officer in an authorized law enforcement patrol vehicle with agency insignia and other jurisdictional markings prominently displayed on the vehicle with siren and lights activated, contrary to Florida Statute 316.1935(2).
