backup officer to respond to the area.

Officers K. Anderson and R. Counts arrived on scene and I approached a white male subject standing just east of the vehicle. As I got closer to him I noticed his white t-shirt collar was stretched. I asked him for identification and he provided his name, identifying him as W/M [REDACTED]. I asked [REDACTED] what occurred prior to police arrival and he stated the following: [REDACTED] stated he met with his ex-girlfriend Lisa at the Jupiter Lanes Bowling Alley (350 Maplewood Dr). [REDACTED] stated he went bowling with Lisa and their son [REDACTED] and Lisa saw text messages from another girl on his phone. [REDACTED] stated Lisa was drinking alcohol in excess at the bowling alley and pulled a receipt from his front left pocket. I looked at the receipt and noticed a large amount of alcoholic drinks were in fact purchased at the bowling alley. [REDACTED] stated after Lisa had several drinks and saw the text messages from another girl on his phone she became upset. [REDACTED] stated Lisa then grabbed [REDACTED] left the bowling alley and entered her vehicle. [REDACTED] further stated he was concerned about Lisa driving intoxicated with [REDACTED] in the car and he got on the hood of the car. [REDACTED] further advised Lisa drove the car with him on the hood of it. I asked [REDACTED] how long he was on the hood of the car for and he stated he was on the hood of the car from the bowling alley until Lisa stopped the car under the E Indiantown Rd bridge. [REDACTED] advised Lisa then exited her vehicle and began to push and scratch him. I asked [REDACTED] if he had any injuries and he motioned to his neck. At this time I saw a fresh scratch on the back right of [REDACTED] neck which was bleeding onto his white t-shirt. Photographs of [REDACTED] and his injury were taken by Officer R. Kolenich.

From my patrol vehicle (#1613) I ran an NCIC/FCIC check on the vehicle registration, and identified Lisa to be the registered owner, W/F Lisa Breen (3/11/87). Breen was on scene, but was initially unable to interact with me because she was screaming and crying. Breen then entered her car and took [REDACTED] from his child seat. Breen and [REDACTED] walked with Officer K. Anderson to the Jupiter Police Harbourside Sub Station, and Officer K. Anderson attempted to calm down Breen.


I then made contact with the other male subject on scene and identified him by name as W/M Richard Morrison (12/31/74). I asked Morrison what occurred and he stated he has been dating Breen for approximately six months. Morrison stated he received a phone call from Breen stating she was in trouble and wanted his help. Morrison stated he lives on a boat by Harbourside and told her to stop underneath the E Indiantown Rd bridge. Morrison further stated because of Breen's demeanor on the phone, he grabbed a hammer from his boat. Morrison advised he saw Breen's vehicle enter the parking lot under the bridge, Breen exit her car and begin to push and scratch her ex-boyfriend. I asked Morrison if he threatened anyone with the hammer and he denied implying anything violent with it, he only brought it because he thought Breen was in danger.

I made contact with [REDACTED] a second time and I asked him if Morrison threatened him with the hammer and he stated "ya, just take him to jail too". I also asked [REDACTED] what [REDACTED] full name was and he identified his son as W/M [REDACTED].


I walked towards the Jupiter Police Department Sub Station where I attempted to speak with Breen for the first time. Prior to speaking with Breen I visually inspected her and noticed no signs of injury on her. I asked Breen several questions pertaining to the physical altercation and she continued to yell "he is a sex offender, get him away from my [REDACTED]". I told Breen I was investigating a battery and she continued to yell obscenities towards myself and other officers on scene. I asked Breen to explain her side of the physical altercation but she continued to yell obscenities such as "hes a fucking drug addict" and also "he is just gonna fuck your kids". Due to Breen's demeanor, and the injuries on [REDACTED] I placed handcuffs on Breen and

escorted her to my patrol vehicle. It should be noted when speaking with Breen I detected the strong odor of an unknown alcoholic beverage emitting from her breath which became stronger as she spoke.

Due to conflicting statements between [REDACTED] and Morrison, and no third party witness, Morrison was released from the scene. Probable cause on Morrison for aggravated assault with a deadly weapon does not exist at this time.

I called Breen's mother to turn over custody of [REDACTED] to her. Breen's mother responded to the area and I identified her by her Florida Drivers License as W/F Sherill Breen (12/3/56). I notified S. Breen of the domestic incident and turned over [REDACTED] to her.

I transported Breen to the Jupiter Police Department holding cell where she continued to yell and threaten me. While in the holding cell Breen told me "I am going to come to your house and put a bullet in your head" and also "I hope your fucking kids get raped". It should also be noted while on scene Breen continued to slip her hands out of the handcuffs, and was kicking on my patrol vehicle windows.

Based on the above described investigation I believe probable cause exists to charge Lisa Breen with simple domestic battery in violation of FSS 784.03(1) (A) (1) because she knowingly and intentionally touched/struck [REDACTED] with the intent to cause her bodily harm. Breen was subsequently transported to Palm Beach County Jail without incident
