

PATEL admitting to the below facts. <input checked="" type="checkbox"/> was found to have committed the below acts, resulting from my (described) investigation.</p> <p>On the 11 day of April, 2018 at 02:42 (Specifically include facts constituting cause for arrest.)</p> <p>The following incident occurred in the City of Delray Beach, Palm Beach County, Florida.</p> <p>I was dispatched to 1909 W Atlantic Ave in reference to a black male and white female doing drugs in a red vehicle (Dodge Dart bearing FL Tag 546YSE). I arrived on scene and met with Ofc. Hutchens and Ofc. Kinney who had already made contact with the subjects in the vehicle. The female was identified by her FL DL as Lisa Nigolian (driver seat) and the male was identified as Gregory Coleman (passenger seat) by Ofc. Hutchens through previous encounters. I could smell a strong odor of marijuana coming from the vehicle. Both subjects were removed from the vehicle. Nigolian stated that there were some drugs in the vehicle that were hers. Nigolian stated that there was cocaine inside of an eyeglass case. Ofc. Hutchens located the eyeglass case on the passenger seat in which it contained a white rock-like substance. There was also a clear baggie that contained a white powdery substance. Inside the case was a clear glass pipe as well. Through my training, knowledge, and experience, I suspected that the white rock and white powdery substance was cocaine. Also through my training knowledge and experience, I know that the glass pipe is often used to smoke the cocaine from. Using a Lynn Peavey Quick Check Test Kit, the white powdery substance and the white rock both tested positive to be cocaine. The residue inside the glass pipe was tested as well which tested positive for cocaine.</p> <p>Coleman was asked if he had any illegal narcotics on him which he stated he had marijuana in his right pants pocket. In Coleman's right front coin pocket was a brown napkin which contained a green leafy substance. The green leafy substance was field tested using a Lynn Peavey Quick Check Test Kit which showed positive results for THC which is found in marijuana.</p> <p>Based on the above-stated facts, probable cause exists to charge Lisa Nigolian with possession of cocaine F.S.S. 893.13(6A) and possession of drug paraphernalia F.S.S. 893.147.</p>
