disturbance. Prior to my arrival, NorthCom advised the caller was being attacked by his girlfriend. I arrived on scene and made contact with caller John G. Auten (W/M 9/24/75). Auten advised me he was just attacked by his girlfriend Lisbeth Lopez Balbuena (H/F, 10/13/92). Auten advised they have been dating for almost a year. I observed Auten's necklace was broken and hanging from his t shirt and he had redness on his left side of his face.

Auten advised Lopez and himself spent the entire day down in Boca. When they got home Lopez and himself went to bed. Auten received a phone call from his friend and left the bedroom to talk. Auten advised he heard loud footsteps coming from behind and then Lopez started to yell at him. Auten advised he is unsure why she was so mad at him. Auten stated Lopez started hitting him in the face and grabbed onto his necklace and ripped it off his neck. Auten went down the stairs to get away from Lopez. Auten advised Lopez followed him down the stairs and outside. Auten stated she kept hitting him while he was on the phone with dispatch. Auten told Lopez he is calling the police and she stated "don't". Auten stated Lopez hurt her ankle when she was chasing after him.

After speaking with Auten, I spoke with Lopez. Lopez was crying and had trouble speaking me in English. Ofc. Batista #439 from Palm Beach Gardens Police Department responded for translation. Ofc. Batista #439 advised me Lopez told him, Auten pushed Lopez because he did not want to talk to her. Lopez advised when Auten pushed her she started to hit him and grab on to him so she wouldn't fall down the stairs. Lopez did not have any visible injuries on her body from where she was push at. She only had an ankle injury from rolling her ankle during the altercation.

I placed Lopez into handcuffs, checked for spacing, and double locked for safety.

Based on above-described, I find probable cause to charge Lopez with simple batter (domestic). Lopez did actually and intentionally touch or strike Auten against the will of Auten did intentionally cause bodily harm to Auten, contrary to Florida Statute 784.03(1)(A)(1)

I issued Auten a Domestic Violence Brochure. His injuries were captured on my body worn camera.


