	On 10/13/2017 at approximately 2244 hours, I responded to 6684 Sweet Maple Lane in reference to a disturbance. Upon arrival I made contact with W/F Lizabeth Pereira, W/M Joseph Worman, W/M Joshua Prince, and W/F Marisol Gutierrez.								
	I made contact with Joseph. Joseph advised that he lives at the above location with Lizabeth, Joshua, and Marisol. Marisol and Joshua are roommates of the house. Lizabeth is Joseph's ex-girlfriend of over six months. Joseph advised Lizabeth came home tonight (10/14/2017) through the garage. I asked Joseph what happened when Lizabeth got into the house and he responded "she started to fight." Joseph said Lizabeth came into his bedroom and started yelling and screaming. I asked Joseph if Lizabeth hit him and he responded that Lizabeth bit him on the finger. I observed a small cut to the top of Joseph's finger on his right hand. Also on the top of Joseph's forearm I observed a fresh scratch mark. I asked Joseph if Lizabeth created those scratches and Joseph responded it's highly possible.								
I spoke with Joshua separately. Joshua advised Lizabeth came home tonight right when she got into the house she told Joseph, Marisol, and him "I can't wait to destroy your evening." When I asked Joshua what happened between Lizabeth and Joseph he responded that Lizabeth "attacked him (Joseph)." Joshua said that Lizabeth went after Joseph like an animal and attacked Joseph. Joshua didn't describe the attack further.									
I spoke with Marisol separately. Marisol said Lizabeth came home and no one expected Lizabeth to be home tonight. Marisol said Lizabeth entered the house and just began screaming and yelling at everyone. When I asked Marisol to explain what happened between Lizabeth and Joseph she responded that Lizabeth just "hit" Joseph. Lizabeth said from what she could see Lizabeth was punching, scratching, and biting at Joseph. Marisol said the fight took place in the hallway in front of Joseph's bedroom and in Joseph's bedroom. Marisol advised the door was open in the bedroom and she could see inside what

I made contact with Lizabeth. Lizabeth advised that Joseph beat her up for over fifteen minutes straight. Lizabeth said that she opened the door to Joesph`s bedroom and Joshua tried to slam it on her. Lizabeth said that Joshua was yelling for Joseph to wake up. Lizabeth said Joseph woke up and started to "beat her up." I observed redness on Lizabeth`s face.

I asked Joshua and Joseph about the marks on I observed on Lizabeth. They both advised she came home with those marks and Joseph was sleeping in his bed. Joseph could not explain the marks further.

It should be noted Joseph advised him and Lizabeth have not been intimate for over six months. Joseph said that he allows Lizabeth to sleep at the house because she doesn`t work, but she comes and goes as she wants and sometimes she doesn`t come home for a few days.

Joseph advised several times that Lizabeth is an ex-girlfriend of over six months and not a current girlfriend.

Joseph, Marisol, and Joshua all advised that when Lizabeth is home she sleeps on the couch and not in Joseph`s room.

Joseph did not want photographs.

Based on the above aforementioned probable cause exists to charge Lizabeth Pereira with the following:
