NOTA  
 FTO Forbes informed me Rodriguez mentioned he and his girlfriend, Lizzette Cabrera (W/F DOB 3/22/73) were involved in an argument. Rodriguez said during the argument Cabrera grabbed a handgun, loaded a magazine into the handgun, racked the slide, and pointed the gun at him. Cabrera was able to leave the residence where he called 911. When asked about the child still inside of the residence, Cabrera advised she is the daughter of the female in question, and is 19 years old.

Officer Allison made contact with the female in question, Lizzette Cabrera, via phone. Officer Allison said Lizzette informed him she did not have a gun and wanted to come out peacefully. At that time, Lizzette peacefully exited the house. Officer Nichols, Sgt Nash, and FTO Forbes and I walked to the front door of apartment 201. Upon getting to the front door we knocked and called the individual who was said to be Cabrera's daughter, Selina Cabrera (W/F DOB 08/31/1997) to the front door. Selina approached the front door and exited the apartment. The above officers cleared the house, ensuring no one else was inside. During our clearing, a handgun was observed laying on the floor of the master bedroom beside the bed. There was also a gun case beside the gun. Upon crime scene retrieval of the firearm it was determined the handgun was a 9MM Norinco bearing a serial number of 26003571; and the gun case contained one loaded and one unloaded magazine.

During my recorded statement with Rodriguez, he stated the following: Rodriguez informed me he and Lizzette have been together for 5 years, and have been living within this residence for 2 years. Rodriguez advised he and Lizzette began to argue in the car on the way home from dancing. He stated when they arrived at their residence the argument continued into the residence and into the master bedroom. Rodriguez informed me Lizzette retrieved her handgun, racked the slide, and pointed the gun at him in the master bedroom, saying get out of my house. I asked Rodriguez if he was scared and he answered "of course." Rodriguez advised Lizzette has owned this firearm since a previous marriage, which was given to her by her ex-husband. He knew the firearm to be a black 9MM and has seen the firearm previously, to know this was the same firearm during this incident.

During my recorded post Miranda interview with Lizzette, she stated the following: Lizzette verbally informed me she understood each of her rights. Lizzette advised she and her boyfriend had been involved in an argument. Lizzette described Rodriguez as a paranoid person. Lizzette said the result of most arguments is the silent treatment. Lizzette told me there is a firearm in the house but she did not know the make or model, just that it is black. Lizzette informed me she has the firearm for protection but has never used it. Lizzette stated the firearm is never out of the case. When asked if there was any reason the firearm should be out of the case tonight, Lizzette advised "I guess I shouldn't talk about it".

Based on the above stated and the statement given by Carlos Rodriguez, I find probable cause to charge Lizzette Cabrera with (1) count of Domestic Aggravated Assault with a Deadly Weapon, pursuant to F.S.S. 784.021
