P R O B A B L E C A U S E S T A T E M E N T On Tuesday June 12, 2018 at 1930hrs, I responded to Macy's, located at 5700 W. Glades Rd, in reference to a shoplifting/retail theft incident. Macy's Loss Prevention Investigator Marie Bros, notified police and reported that Loss Prevention apprehended a 31y/o female, after she was observed taking numerous pieces of clothing, valued at \$839.97 Upon arrival, I met with Bros who was the investigator that apprehended Lorena Romero Delgado. Bros told me that she first observed Delgado enter into the Lacoste Department. Delgado was already holding preselected merchandise and a purse that appeared empty. While in the Lacoste Department, Bros observed Delgado select four Lacoste shirts. After selecting the four shirts, Delgado proceeded to the Calvin Klein Department. Once again, Delgado selected more clothing and proceeded to the second floor. Once on the second floor, Delgado entered into the Women's Department and selected numerous pieces of clothing from the display racks. Delgado then entered into a fitting room with all clothing in hand. A couple minutes later, Delgado exited the fitting room but her purse appeared to be bigger. Bros quickly checked the fitting room and no clothes were left behind. Once Delgado exits the fitting room, she is seen selecting more clothing from Calvin Klein and from INC. Delgado re-enters into the fitting room and comes out minutes later with less clothing in hand. This process is repeated one more time as well. Bros checked the fitting on both occasions and no clothes were left behind. Delgado then makes her way to the escalator down to the first floor, where she is seen walking towards the mall entrance/exit. Keeping constant CCTV/floor surveillance on Delgado, she is observed passing all points of sale, not making an attempt to pay for the merchandise and exiting Macy's through the mall entrance/exit. Delgado was apprehended by Bros and all merchandise was recovered.
