## PROBABLE CAUSE

On June 10, 2017 I was on routine patrol in my marked patrol vehicle in Palm Beach County. I arrived on the scene of Cedar Point and Military Trail to assist Palm Beach Sheriff's Office Deputy A. Swigert. Once I arrived scene Deputy Swigert advised me that he observed a black vehicle with a Florida tag of 527YIH stopped at the stop light of eastbound Cedar point and Military Trail (State Road 809). Deputy Swigert advised that he observed the vehicle stopped at the light and watched the light cycle from red to green multiple times. He then observed the driver of the vehicle put the vehicle into reverse and reverse the vehicle. The driver then stopped and threw the keys out of the driver's side of the vehicle. He was then asked by the deputy to step out of the vehicle. In doing so he was unable to maintain balance and walked backwards. Deputy Swigert stated to me that he smelled the odor of an unknown alcoholic substance emitting from the driver's breath. The driver was later identified as Louis Sanet by his Florida Drivers License.

I observed Mr. Sanet to be sitting on the curb of the roadway. I introduced myself and asked Mr. Sanet to stand up and talk to me. He then hesitated and did not want to stand. In talking to Mr. Sanet I smelled the odor of an unknown alcoholic beverage emitting from his breath and body. I also observed that his eyes were bloodshot red and glassy. I then requested that Mr. Sanet complete roadside exercises. Mr. Sanet verbally and physically indicated that he was willing to conduct them.

## Horizontal Gaze Nystagmus

Before beginning the exercises, I checked to see if Mr. Sanet was wearing glasses or contact lenses. It was determined that Mr. Sanet was not wearing glasses or contacts. I then checked Mr. Sanet's eyes and observed equal tracking and equal pupil size. Mr. Sanet was instructed to place his feet together and place his hands down at his side. He then was instructed to keep his head still and follow the stimulus with his eyes and his eyes only. He was also instructed to keep looking at the stimulus until told not to. Mr. Sanet verbally indicated that he understood. During the exercise I observed 5 of the 6 possible clues.

- Lack of smooth pursuit, left eye
- Lack of smooth pursuit, right eye
- A distinct and sustained nystagmus at maximum deviation in the left eye
- A distinct and sustained nystagmus at maximum deviation in the right eye
- An onset of nystagmus prior to 45 degrees in the left eye
- An onset of nystagmus prior to 45 degrees in the right eye

I also observed vertical nystagmus.

During the exercise Mr. Sanet had to be told to stay in the proper position and not to move his head during the exercise. I also observed Mr. Sanet to have orbital sway and glassy red eyes.

## Walk and Turn Exercise

JUN 10 AM 8:52

Mr. Sanet indicated that he had medical problems with his hip. The area was level and free of debris. Mr. Sanet verbally indicated that he saw the line on the ground. Mr. Sanet was instructed to put his left foot on the line, then place his right foot on the line ahead of the left foot in a heel to toe manner. I then demonstrated this position. Mr. Sanet was instructed not to begin until told to do so. Mr. Sanet verbally indicated that he has understood all instructions up to this point. Mr. Sanet was then instructed to take 9 heel to toe steps on the line when told to do so. I then demonstrated this. Mr. Sanet was then instructed to turn on the ninth step and to keep the front foot on the line and to take a series of small steps with the foot on the line. I then demonstrated this for Mr. Sanet. Mr. Sanet was also instructed to keep his arms at his sides and to watch his feet during the exercise. Mr. Sanet was also instructed to count aloud and to not stop once he begins the exercise. He was also instructed to keep his arms at his sides at all times.

Mr. Sanet began the exercise too soon and had to be told to wait and to get back into the starting position. Mr. Sanet began the exercise and stepped off the line on all steps. Mr. Sanet also did not count aloud and showed difficulty keeping balance. Mr. Sanet also completed the incorrect number of steps. He took 13 steps forward. While completing the turn Mr. Sanet took both feet off the line and incorrectly completed the turn. Mr. Sanet also raised his arms more than 6 inches multiple times. Mr. Sanet also took 13 steps back. He never touched heel to toe and did not count aloud.

## One Leg Stand Exercise

Mr. Sanet was instructed to stand with his feet together and to place his arms down at his side. Mr. Sanet was instructed to maintain that position until told to do so. Once told to do so, Mr. Sanet was instructed to raise one foot approximately 6 inches off the ground and to keep both legs straight with both arms at his side. He was also instructed to look at the elevated foot and count aloud in the manner of one thousand-one, one thousand-two and so on until told to stop. Mr. Sanet verbally indicated that he understood the instructions after I demonstrated to him.

Mr. Sanet was told to begin and raised his right foot. During the exercise Mr. Sanet displayed an orbital sway and had to use his arms multiple times to keep from losing balance. He also did not raise his foot six inches off the ground or keep both legs straight. He raised his foot approximately 8 inches off of the ground. Mr. Sanet also did not count aloud properly as instructed. Mr. Sanet placed his foot down multiple times during the exercise and bounce while trying to maintain balance. Mr. Sanet did not look down at his foot during the exercise.

While inside of my patrol vehicle Mr. Sanet complained multiple times that the handcuffs were to tight. I then re adjusted the handcuffs and insured that they were placed on correctly. Mr. Sanet was then transported to the county jail. Once arrived at the breath testing center Mr. Sanet was observed for 20 minutes. At no time did he regurgitate or ingest anything by mouth. At approximately 0627 am Mr. Sanet refused to submit to a lawful test of his breath. He was then booked into the county jail. The above incident occurred in Palm Beach County.

The light at the intersection was red and had cycled green, then back to red. The vehicle did not move, and several vehicles had to drive around the black vehicle that was stopped in the path roadway. I asked the driver of the vehicle to park his vehicle, so that he does not disrupt the flow of traffic. The driver then put on the hazard lights of his vehicle, and reversed the vehicle westbound on Cedar Point Drive several feet. I pulled behind the vehicle and signaled my horn to have the vehicle move out of the roadway. The driver of the vehicle, Identified by his issued Florida Driver's License, Louis Sanet, pushed his driver's side door open and threw his keys onto the roadway. 3. You have the right to the presence of a lawyer of your choice before you make any statement and during any questioning.
4. If you cannot afford a lawyer, you are entitled to the presence of a court appointed lawyer before you make any statements and during any questioning.
5. If at any time during the interview you do not wish to answer any questions, you are privileged to remain silent.
6. I can make no threats or promises to induce you to make a statement. This must be of your own free will.
7. Any statement can and will be used against you in a court of law.
