On 12/22/2019, at approximately 1521 hours, I responded to 400 US Highway 1 (Frigate's Waterfront Restaurant) in the city limits of North Palm Beach, FL for a disturbance. North Regional Police Communications advised there were two subjects, a male and a female that were causing a disturbance. The female, later identified as Lourdes Asiaain 08/23/1993, was causing an altercation with another female server. Both the male and Asiaain were flipping over tables and then they proceeded outside and were causing a disturbance with valet. On arrival, contact was made with the male and Asiaain. It should be noted, I arrived in my marked Village of North Palm Beach Police Department vehicle, with emergency lights activated, and I was wearing my issued North Palm Beach Police Department uniform that clearly identifies me as a law enforcement officer. While talking with Asiaain and the male, I was able to detect the overwhelming odor of an unknown alcoholic beverage emitting from their person. Both the male and Asiaain were asked for their identifications. The male readily handed over his identification. I again asked Asiaain for her identification. Asiaain asked, "Why." I explained to Asiaain why she needed to hand me over her identification. Asiaain stated, "No." I further tried to explain to her why she needed to produce it and if she still refused to produce it, she would be arrest and booked into Palm Beach County Jail. Asiaain looked right at me and stated, "I want my attorney." Due to Asiaain refusing to produce her driver's license during the course of an official investigation, I walked over to place Asiaain under arrest. While both my hands were on her wrist and attempting to restrain her, she began to yell, "Record this" numerous amounts of times she would not stop causing a further disturbance by yelling. I told her several times to stop resisting and she was under arrest; however Asiaain kept yelling. I opened the right rear marked North Palm Beach Police Department vehicle #397. I attempted to place her inside of it, yet Asiaain refused to sit down in the vehicle. I attempted to assist her inside of the vehicle and she kept her body stiff, yelling, "Record this." I attempted several times to get Asiaain to sit by herself in the

rear of the car. Asiain kept her body completely stiff and therefore required assistance with me putting her into the rear of the vehicle. As she was in the back of the seat, she laid down which caused me to reach in and help sit her up so that she could be properly restrained in a seatbelt as outlined by North Palm Beach Police Department Policy. While leaning in, Asiain willfully and intentionally took her foot and kicked me in the center of my chest. It should be noted this was a complete and unwanted touching from Asiain towards me. I was able to secure Asiain in a seatbelt. It should be noted; I was able to detect an overwhelming of an unknown alcoholic beverage emitting from her breath. Contact was made with the manager, W/F Geraldine Chavez 11/24/1992. Chavez stated that the male was approaching guest so they asked him to leave. While trying to have the male leave, Asiain "Became hostile with me and would not accept that we wanted the guy gone. She approached our server and attempted to fight her because they were both asked to leave." Asiain was transported to North Palm Beach Police Department for all paperwork. Asiain was transported to Palm Beach County Jail.
