### DRIVING PATTERN:

Vehicle was traveling northbound in the 200 block of Old Dixie Hwy. within the Village of Tequesta, Palm Beach County Florida. The vehicle failed to stop at a steady red light at the intersection of Tequesta Drive and Old Dixie Hwy. The vehicle accelerated up to a speed of 58 mph on a 40 mph zone. The vehicle turned eastbound on the corner of Village Blvd and Old Dixie Hwy. 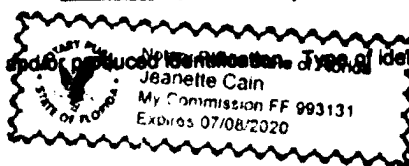
