NARRATIVE:

Based on the supplemented probable cause affidavit provided by Sgt B. Cullen I have probable cause to arrest Luis Martin Preiss for Resisting Officer without Violence per FSS 843.02, as he did unlawfully resist, obstruct and oppose Sgt Cullen ID#7651, a law enforcement officer of the Palm Beach County Sheriffs Office, in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer.

In addition while D/S Booras was attempting to assist Preiss in to the rear prisoner compartment of D/S Sanders' marked patrol vehicle, Preiss again tensed up his body. He began stiffening his arms and legs in attempt to resist entering into the rear prisoner compartment. Preiss was given multiple verbal commands to comply and enter into the rear prisoner compartment. Preiss then violently twisted his body attempting to thrust his elbow into D/S Booras.

Also as he did he grabbed ahold of D/S Booras' inner left forearm and dug his fingernails into his skin causing redness and scratch marks on his inner forearm. Based on the above facts I Also find probable cause to arrest and charge Preiss with



On the 14 day of April 20 18 at 0406 A.M P.M (Specifically include facts constituting cause for arrest.)

On Saturday April 14th, 2018 at 0406 hours Sgt. Jezewski #7245 observed a black Acura, FL tag EBP5Q along the CSX railroad tracks in the 6000 block of Beeline Hwy, unincorporated West Palm Beach. The vehicle appeared running with the headlights on. I arrived in full PBSO uniform moments later and we approached. My marked patrol vehicle with emergency lights activated was adjacent to the Acura. I noticed the driver (sole occupant) was passed out behind the wheel. The vehicle was running, in drive with the headlights on. The vehicle was partially against the tracks to the point a train would have collided with the vehicle had it come through. The driver had his arms crossed, head back and eyes closed and appeared to be smirking and talking in his sleep. Myself and Sgt. Jezewski banged on the windows several times and used the flashlight in an attempted to wake the subject. After 3-5 minutes of this, the subject became more alert and slammed on the gas. The vehicle tires spun. The subject was then ordered to put the car in park, which he complied, which unlocked the doors.

The subject was then ordered out of the vehicle at which time he yelled "IM 17". I attempted to escort him away from the tracks by his right arm for his safety, but the subject was non-compliant. I ordered him to walk away from the tracks for his safety and he refused. He began agitated and began screaming. Once he clenched his fist and tensed his arm I quickly recognized this as a posture for a fight and escorted him to the ground. He began fighting my efforts to handcuff him despite several commands to comply and place his hands behind his back. Sgt. Jezewski and I were able to defeat his resistance and get him handcuffed. Once additional units responded we were able to escort the subject to the road, which was approximately 150 feet away. The subject the entire time was resisting, pulling away, and trying to defeat our escort. Once at the patrol vehicle the subject continued his resistance, but was eventually secured without incident or injury. The subject was later identified by deputies as Luis Preiss.

This concludes my involvement.
