While at the address of 5447 Center street, Jupiter, Palm Beach County Florida conducting a drug investigation linked to a noise complaint at an open house style party, I was assisted by Ofc Borrows of Jupiter Police department who located the defendant in the patio area of the house. Ofc Borrows identified a jacket that the defendant advised belonged to her and as she reached for it a clear baggy with a pink powder inside fell from the jacket. Ofc Borrows recognized the power as illicit (ecstasy) and detained the defendant. I second clear baggy containing pink powder was located in the jacket pocket. Ofc Borrows relocated the defendant to my location in the front driveway where i field tested the pink powder with a Sirchie NARK #15 test kit which yielded a positive result for MDMA (ecstasy). Defendant provided a post miranda statement (read to her in spanish by D/S Dorta 6395) that she got the drugs at a concert in Miami on 3/30/18 and knew it was illegal drugs but wasn't sure exactly what kind of drug it was. She last snorted the drug at approximately 4:30 am when she arrived at the house party. Probable cause exists for her possession of ecstasy is in violation of FSS 893.13 (6) A
