On 1/8/17 at approximately 2:11 a.m. myself and Officer Artola #452 were at the PGA Plaza with a yellow cab and an male having difficulty paying, when a black 4 door car turned into the plaza from Prosperity Farms Road. The car, jumped the curb taking out the tow away zone and proceeded across the other side of the curb, and then jumped another curb before coming to rest across from the Chase bank in the PGA plaza. I drove around to the front of the bank as Officer Artola went to the vehicle. Officer Artola observed a white female that was driving the vehicle. When the vehicle stopped, Officer Artola observed a white male exit the passenger door as he approached the driver.

## OBSERVATION OF DRIVER:

The driver, was identified by the photograph on her Florida drivers license as Madeline Emily Faller. Officer Artola smelled an odor of an unknown alcoholic beverage coming from the drivers breath, when she exited she was stumbling. When I made contact I observed that her eyes were very red and she was having mood swings. Faller has a strong odor of an unknown alcoholic beverage coming from her breath as she spoke, her speech was slurred, she was having prominent mood swings, she was unsteady on her feet, swaying and stumbling as she stood.

stated she had a couple of drinks, stated she has anxiety and alcohol helps her.

strong odor of an unknown alcoholic beverage coming from her breath as she spoke
