
On Friday 6/30/17 at approximately 1953 hours I was dispatched to Walgreens in Bluffs Square (4050 S US Highway 1) in reference to the suspect in this case W/F Madysen Rosenberg (5/17/93) returning to the business. While en-route, Northcom sent me Rosenberg's drivers license information and I was able to view a picture of her. Northcom also provided me notes for the initial call which stated Rosenberg entered the business with a gatorade, asked a Walgreens employee for a bag, and then put milk, butter, and a blanket in the bag passing all points of exit and leaving the business. The initial call notes indicate a theft of \$23.17.

Upon my arrival I witnessed Rosenberg being escorted out of the business by Officer R. Kolenich. I witnessed Officer R. Kolenich read Rosenberg her Miranda Rights and at the conclusion of being read her rights Rosenberg acknowledged she understood them.

I entered Walgreens and made contact with the Walgreens shift leader "Pamela" who advised Walgreens wishes to press charges for the retail theft which occurred earlier in the day. "Pamela" also gave me a copy of the video surveillance for the retail theft, and provided me the phone number for the Walgreens manager Maureen who was present at the time of the initial theft (#561-371-8354). Maureen and Pamela both advised they want Rosenberg indefinitely trespassed from the business.

I exited Walgreens with the surveillance video and told Rosenberg "I have the video surveillance from earlier, what am I going to see on here" and she replied "you will see me shoplifting". I asked what items she stole from the business and she replied "milk and butter". Rosenberg then stated she does not currently have money to afford those items.

In my patrol vehicle I watched the surveillance video which shows Rosenberg enter Walgreens at 1157 hours, wearing white pants, a grey tank top and black shoes. Rosenberg




then gets a Walgreens bag in the pharmacy area at 1203 hours, conceals several items and then walks out the main entrance with the concealed merchandise passing all points of sale at 1204 hours.

Based on the above described supplemental investigation and Rosenberg's confession, I believe probable cause exists to charge Rosenberg with retail shoplifting in violation of FSS 812.015(1) (D). Rosenberg was issued a NTA and an indefinite trespass and left the area with her boyfriend.

WALGREENS	THEFT - RETAIL (SHOPLIFTING)	

On Friday, June 30, 2017, at approximately hours, I responded to Walgreens, 4050 S. US Highway One, in reference to a retail theft. Upon my arrival I met with, and introduced myself to, store manager Maureen Mercier (w/f 10/19/1970) and she told me the following:

While working in the store, Mercier said she has seen Madysen Taylor Rosenberg (w/f 05/17/1993) come into the store several times and she knows Rosenberg's identity due to Rosenberg being a customer at the store's pharmacy. Mercier told me that she suspected Rosenberg of shoplifting at least once before but did not witness the theft and was unable to see the theft occur on the store security camera video. Mercier said that she saw Rosenberg come into the store today (at approximately 11:59 hours) and noticed that she walked in carrying a bottle of Gatorade and a purse over her shoulder. She told me that she continued to watch Rosenberg as she moved around the store with a shopping cart. Mercier told me that she saw Rosenberg take milk (Borden 1/2 gallon, retail price \$3.19) and butter (Nice brand butter, retail price \$3.99) from the refrigerated section of the store. Mercier said she attempted to keep a constant watch on Rosenberg as she shopped but was unable to. Mercier said that she saw Rosenberg pushing the cart, with the milk, butter and a blanket (Sol Sherpa Throw 50"x60" retail price \$15.99) towards the pharmacy counter (at approximately 12:03 hours) and so she stopped watching her as she believed Rosenberg was going to pay for the items at the pharmacy counter.

Mercier told me that she went back to the front of the store. At approximately 12:04 hours she saw Rosenberg walking out of the store carrying a plastic Walgreens bag with items in it. She said Rosenberg had not paid for any items at the front of the store and so she pulled up the transaction register for the pharmacy. Mercier told me that there was no transaction for the items she had seen in Rosenberg's shopping cart and so she went back to speak with the pharmacy cashier, Guerline Pierre (b/f 06/20/1996). Mercier said she discovered that Rosenberg had asked Pierre to refill a prescription for her and asked Pierre for a bag, which Pierre gave to her. Rosenberg told Pierre she would return later in the day to pick up her prescription and made no attempt to pay Pierre for the items that she placed in the Walgreens bag.

Mercier reviewed the store security video and confirmed that Rosenberg had walked up to the pharmacy counter with the milk, butter, blanket and another undetermined item in her hands and then placed the items on the floor while speaking with the cashier. The video shows Rosenberg speaking with Pierre, Pierre giving her a bag and Rosenberg bending down to the floor, bagging the items. It also shows Rosenberg walking out of the store with the Walgreens bag.

Mercier told me that she had the authority to provide a sworn written statement and request prosecution on behalf of this Walgreens store. She also told me that she wanted a trespass warning issued to Rosenberg.

I spoke with Pierre and she confirmed that Rosenberg had come to pharmacy counter and asked to refill a prescription. Pierre said that Rosenberg provided necessary information to request the refill and then asked for a plastic bag for the items she was holding. Pierre told me she gave Rosenberg a bag and didn't realize that she needed to verify that the items had been paid for. She said that Rosenberg's records show that she lives in Delray Beach, per her Florida driver's license. Pierre completed a sworn written statement and it is submitted with this report.

Ofc. Bernstein (ID 318) had also arrived at the store. He had requested that NorthComm run Rosenberg and he was provided with a local address of 206 Mainsail Circle, Jupiter. I reviewed the call history at this address and, on March 8, 2017, PBSO made contact with Rosenberg at this location. Ofc. Bernstein went to 206 Mainsail Circle and knocked on the door several times but got no response.

I ran Rosenberg's information on my MDT and discovered that she is currently on probation. I contacted the Probation Office by phone but was unable to speak with Rosenberg's assigned Probation Officer. I was transferred to the on-duty Supervisor but was only able to leave a message regarding my investigation and evidence regarding the retail theft (shoplifting) and that Rosenberg would be charged with a misdemeanor pursuant to F.S.S. 812.015(1)(D).

I returned to Walgreens to speak with Mercier and pick up a copy of the store video. I explained to Mercier that I had been unable to locate Rosenberg. I asked that, when Rosenberg returned to pick up her prescription, the pharmacy stall Rosenberg while someone from the store called Jupiter PD to return to the store and arrest Rosenberg for shoplifting and issue a trespass warning.

The video was submitted into Evidence. At the end of my shift, 16:45 hours, Walgreens had not called, nor had the probation office.

Upon returning for duty on July 1, 2017, I discovered that Ofc. Conner had responded to Walgreens during his shift. He was able to make contact with Rosenberg at the store, complete a supplemental investigation (including post-Miranda confession) and issue an NTA for retail theft along with a trespass warning.

Nothing further to report - case closed by arrest.

On Friday 6/30/17 at approximately 1953 hours I was dispatched to Walgreens in Bluffs Square (4050 S US Highway 1) in reference to the suspect in this case W/F Madysen Rosenberg (5/17/93) returning to the business. While en-route, Northcom sent me Rosenberg's drivers license information and I was able to view a picture of her. Northcom also provided me notes for the initial call which stated Rosenberg entered the business with a gatorade, asked a Walgreens employee for a bag, and then put milk, butter, and a blanket in the bag passing all points of exit and leaving the business. The initial call notes indicate a theft of \$23.17.

Upon my arrival I witnessed Rosenberg being escorted out of the business by Officer R. Kolenich. I witnessed Officer R. Kolenich read Rosenberg her Miranda Rights and at the conclusion of being read her rights Rosenberg acknowledged she understood them.

I entered Walgreens and made contact with the Walgreens shift leader Pamela who advised Walgreens wishes to press charges for the retail theft which occurred earlier in the day. Pamela also gave me a copy of the video surveillance for the retail theft, and provided me the phone number for the Walgreens manager Maureen who was present at the time of the initial theft (#561-371-8354). Maureen and Pamela both advised they want Rosenberg indefinitely trespassed from the business.

I exited Walgreens with the surveillance video and told Rosenberg "I have the video surveillance from earlier, what am I going to see on here" and she replied "you will see me shoplifting". I asked what items she stole from the business and she replied "milk and butter". Rosenberg then stated she does not currently have money to afford those items.

In my patrol vehicle I watched the surveillance video which shows Rosenberg enter Walgreens at 1157 hours, wearing white pants, a grey tank top and black shoes. Rosenberg then gets a Walgreens bag in the pharmacy area at 1203 hours, conceals several items and then walks out the main entrance with the concealed merchandise passing all points of sale at 1204 hours.

Based on the above described supplemental investigation and Rosenberg's confession, I believe probable cause exists to charge Rosenberg with retail shoplifting in violation of FSS 812.015(1)(D). Rosenberg was issued a NTA and an indefinite trespass and left the area with her boyfriend.
