




In the City of Riviera Beach, Palm Beach County, Florida, the following incident occurred: On Saturday, August 19th, 2017, at approximately 10:45AM, Riviera Beach Police officers responded to 7289 Garden Rd. (Wawa gas Station) in reference to Petit Theft. The General Manager Carlo Lucci W/M 09/04/1968 advised dispatch that a male ran out of the store without paying for two cases of beer. Lucci then advised that the male was hiding in bushes on Garden Rd. just south of the store. Officer J. Harvey #6346 arrived on scene and observed the male, later identified as Maher Hammad W/M 11/18/1990, crouched down in the bushes holding the two cases of beer. Officer Harvey detained Hammad and recovered the two cases of beer which were later returned to the store. I later made contact with Lucci who advised the following: At approximately 10:35AM, he was contacted via walkie talkie by an associate who advised Hammad was walking around inside the beer cooler as if he was casing the store. Lucci stated because of recent thefts of beer, employees had been instructed to keep an eye out for suspicious individuals in the beer cooler. At approximately 10:38AM, the associate radioed to Lucci that Hammad left out of the back door. Lucci advised he then saw Hammad exit the back door, passing all points of sale, and run south east through the parking lot holding two cases of beer. Lucci advised he followed behind Hammad to see where he was going, when he saw him hide in the bushes along Garden Rd.

I observed the store surveillance footage which confirmed Lucci's account of the incident. Lucci gave a sworn recorded statement and is requesting prosecution. Lucci signed an Affidavit of Complaint and was given a Victim's Rights Brochure.				
While at the Riviera Beach Police Station, Hammad began to complain of chest pain therefore he was transported to St. Mary's Medical Center for medical clearance. Hammad was later transported to the Palm Beach County Jail.
