

	<p>On Saturday, December 16, 2017, at 0254 hours, I responded to 86 Lighthouse Dr. in reference to mutual aid for Jupiter Inlet Colony Police Department. The call was in reference to a domestic battery. Upon my arrival, the homeowner Denise Cassell (W/F 12/6/66) advised that she would like a W/F removed from the residence and trespassed. Cassell advised the female later identified as Makensi Karbowski (W/F 9/29/94) was on the back patio intoxicated and was the cause of her sons getting into a fight.</p> <p>Officer Kolenich and I approached the female on the back patio and told her she needed to gather her belongings and leave the property and never come back. She continued to sit down and I asked her again to leave. She eventually stood up, but was not walking to an exit. After multiple requests of asking her to leave Officer Kolenich and I took her by the arms to lead her out. While we were escorting her she asked if she could just walk herself, but when we let go she stopped moving and would not step forward. We again escorted her until we got to the front yard. Once we were in the front yard I asked her to wait by the patrol car to get off the property and call a ride to come pick her up. She refused to call anyone and was still refusing to leave the property entirely. She tried to make her way back towards the house and I took her by the wrist to stop her from going back. She then grabbed me by my wrist. I pulled her hand off my wrist and we placed her in handcuffs. I then placed her in the back of my patrol vehicle. While she was in the back of my patrol vehicle, she continually yelled derogatory terms at me and threatened to kick my ass.</p> <p>I arrived at the Jupiter Police Department holding cells with Karbowski and Officer Counts was there to assist me bringing her in. I brought her up to an area against a wall to complete a search and take off the handcuffs. I asked her to place her hand on the wall above her head, but when it was released she would not. She advised she needed to use the restroom, so the handcuffs were removed. When she went into the restroom she tried to shut the door when I told her it needed to remain open and I had to force it to</p>

remain open. After she was finished using the restroom she walked out and I told her to walk into cell # 2. She would not walk into the cell and did not listen to my commands. She tried to walk out the opposite way of the holding cells. As I was walking up to her to stop her and place her back in handcuffs for resisting, she took a hold of both of my wrists. I gave her commands to release them, but she did not. Officer Counts then escorted her to the ground so we could place her in handcuffs. While on the ground she continued to fight us. She was repetitively told to stop resisting. I was able to put the handcuffs on and she was hobbled. She continued to resist and would not walk. She continued to curse and threaten that she would beat me up.

Once she was transported to Palm Beach County Jail, the PBSO corrections deputies were assisting to bring her in and she attempted to fight them and resisted their commands when being escorted.

The above circumstances gave me probable cause to charge Karbowski with trespass after warning, resisting arrest, and 2 counts of battery on a LEO.
