PROBABLE CAUSE

I was dispatched to a crash, reported as a Porsche going off the exit and overturning, northbound SR-9 on the exit to SR-706 eastbound. I checked the location and found no vehicle or evidence of a crash. I was then dispatched to a hit & run crash, northbound on SR-9 near Donald Ross Rd, with the victim waiting on Donald Ross Rd east of SR-9. I made contact with the victim (Wolfe), and observed damage to the left rear of his vehicle. He stated he was driving northbound in the center lane of SR-9 when a dark colored Porsche approached him from behind at a high speed, then collided with the rear of his car. As he pulled to the shoulder, the Porsche continued northbound without stopping, smoking badly. I collected his vehicle and driver information, gave him a case number and returned to the area of SR-9 at SR-706.

I checked the northbound exit ramp to westbound SR-706. There is a guardrail running north along the right shoulder, and a separate guardrail that follows the left edge of the exit ramp. There is approximately a 20' gap between the two ends of the guardrails leading down a steep embankment to the north and knees next to the car with his head on the passenger seat. The passenger door was opened and I could see a person on his approximately 50' away, the person (defendant) stood up. He faced me and immediately said "I wasn't driving". I asked if he was okay and he repeated that he wasn't driving. I asked who was driving and he said the other person. There was no one else in sight, and the terrain was very steeply uphill in all directions.

Defendant was having a very difficult time standing. There was just a spot of blood on his left ear, and an abrasion on his left cheek. He had a strong sour odor of an unknown alcoholic beverage about his person. His pants were wet. He speech was very slurred and difficult to understand. He spontaneously said he was at his friend's party and had a glass of wine. He said the was a big truck that cut him off. I searched the surrounding area and saw no sign of another person, no footprints in the soft earth or broken grass indicating someone walking or crawling away. I asked defendant if he was able to walk. He my car's lights. Defendant stumbled several times and kept pulling away from me.

When we climbed up to where my car was, PBCFR, Rescue 16 was arriving. Defendant would not give a direct response as to whether or not he was injured. He was clearly dazed and confused. The EMTs immediately assisted him into the Rescue and transported him to Gardens Medical Center. I requested a tow. Trooper M Gubbish (999) waited for Kauff's towing and I responded to the hospital.

When I arrived, defendant was in a treatment room. the nurse advised me that he had already been seen, and they were waiting to give him a tetanus shot and he was ready for discharge. I identified myself, again, and told him I had completed my crash investigation and was conducting a criminal investigation for leaving the scene of a crash and for DUI. I read Miranda, defendant kept interrupting and asking to call his partner - he is a radiologist at Gardens Medical Center. I asked him if he would submit to a blood test and he asked to call his lawyer. I read Implied Consent and asked if he would submit to a blood test. He said no, he wanted to call his partner (Dr. Brian Young).

Defendant was agitated and giving the nurse a hard time, demanding water, cursing and demanding they call his partner. He refused the tetanus shot, and was provided discharge papers. I arrested defendant and transported him to the Palm Beach Count Jail.

In car video was not active at the scene (the car was below and out of range for the camera, and out of range for the remote mic). I did not activate it in the emergency room for the same reason. When I had secured defendant in my car, I activated the camera. He was cursing and ranting the entire drive to jail, angry because the hospital staff would not give him water, ranting about his status as a doctor, saying he was a good person.


