On the _____ day of _____ 20____ at _____ A. M. P.M. (Specifically include facts constituting cause for arrest.)

On 02/23/2018 at approximately 1015Hrs I was dispatched to 1072 Madison Chase Apt. 4 in West Palm Beach, FL, Palm Beach County, in reference to a domestic disturbance.

Upon arrival, I made contact with Karlos Herrera in front of the residence. I observed that Karlos had a black/blue knot on his right cheek bone and was bleeding from his mouth. Karlos also had visible scratches to his neck. Karlos advised that he was involved in a physical altercation with his girlfriend, Marcela Espinoza, with whom he lives with at the residence. Karlos stated that the two were involved in an argument at which point Marcela began to open their bedroom window located on the second floor and throw his personal items out of the window. Karlos stated that he attempted to grab onto a box that she was going to throw out to which he was able to take out of her grip. According to Karlos, Marcel became enraged and physically attacked him by punching him in the face with a closed fist. The physical altercation continued and Marcel began to scratch his lower face to chest area leaving visible and fresh scratch marks.

I made contact with Marcela Espinoza in her bedroom. Marcela stated that they were indeed arguing and began to throw his items out of the window. She stated that he tried to stop her by grabbing her neck and then smacking her in the face. Marcela stated she called 911 and that Karlos hit himself causing the marks. Marcela pointed out that she had a scratch mark on her neck and a mark on her face where Karlos allegedly smacked her.

Photos were taken of the injuries to both Karlos and Marcela. There were no independent witnesses to this incident.

Based on the totality of the circumstances there is probable cause to effect an arrest on Marcel Espinoza for domestic battery (FSS 784.03 1a1) as all indications led me to believe she was the primary aggressor. Marcel was placed into handcuffs (to include double locked and checked for tightness) and placed in the rear of a Palm Beach Sheriff's Office marked vehicle. Marcela was transported to Palm Beach County Main Jail without incident where she was turned over to correction personal for processing.
