# D.U.I. PROBABLE CAUSE AFFIDAVIT

**DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)**

On Sunday, February 19, 2017 at approximately 0200 hours, while conducting speed enforcement in the 12000 Block of Southshore Boulevard, Wellington (Palm Beach County) Florida, I watched a gray small vehicle enter onto the boulevard from Vinings Circle without stopping. The vehicle made a right turn into the inside lane and proceeded westbound. I drove behind the vehicle with the intentions of stopping it for the previously mentioned violation that I observed. While behind the vehicle I watched it weave inside the inside lane and nearly struck the median on one occasion. I activated my emergency lights in an effort to stop it. The vehicle slowed and made a U-turn at a break in the median. It slowly traveled alongside the shoulder of the roadway before stopping. I exit my patrol car and began approaching the vehicle from the driver side. The vehicle began slowly moving forward. I yelled for the driver to stop while shining my flashlight at the side mirror of it. The vehicle stopped and the driver side door opened. I made contact with a white male subject who was the single occupant of the vehicle. I told him he was being stopped for entering onto the roadway without stopping. I asked for his driver license, registration and proof of insurance. During this time I could smell a strong odor of an unknown alcoholic beverage coming from the inside of the vehicle. I also noticed the driver's eyes were clear and glossy. I told him I had a suspicion he had been drinking an unspecified amount of unknown alcoholic beverages. This prompt me to proceed with a DUI investigation to determine if he was impaired while operating his vehicle.

## OBSERVATION OF DRIVER:

I later identified the driver as Marcus Nathaniel Haggard by his Swedish driver license. In addition to the previously mentioned indicators, his mouth was dry and cheeks were flushed. I could smell a strong odor of an unknown alcoholic beverage emanating from his breath that intensified when he spoke to me after he was out of his vehicle. He was unsteady while standing and was unable to maintain his balance while walking. I asked if he would consent to performing Standardized Field Sobriety Evaluations (SFSTs) for the purpose of determining if he was impaired while operating a motor vehicle. He consented to performing the SFSTs. I asked if he had any physical problems with his body that would inhibit him from performing light physical movements. I also asked if he was on medication. The defendant told me he had problems with his knees, but was not taking medication. The following SFSTs were explained, demonstrated and acknowledged by him prior to his performance: HGN, The Walk and Turn, The One Leg Stand, The Finger to Nose and The Romberg Balance Test. During the Romberg Balance Test he was asked to stand with his feet together, tilt his head back and close his eyes. While in this position he was asked to allow the passage of 30 seconds in his mind without counting aloud. Once he reached the passage of 30 seconds, he was asked to return his head to its normal setting, open his eyes and say the word "Stop". During this evaluation he allowed 37 seconds to pass before completing this evaluation. The SFSTs were administered on a smooth and level surface that was free from obstructions and debris. The area was well lit by the lighting from my patrol car. His deficiencies were recorded on another form on this worksheet.

## DRIVER'S STATEMENTS:

Post Miranda the defendant said he drank four (4) glasses of wine. He also told me he drank cocktails with friends at The Grill.

Strong odor of an unknown alcoholic beverage coming from his breath.



**Other Observations:**

Subject was asked to stand with their feet together and place their hands by their side. They were asked to focus on the stimulus and follow it with their eyes. Lastly they were told not to move their head to assist in following the stimulus with their eyes. During this evaluation subject often turned his head to assist his eyes in following the stimulus.

**WALK & TURN:**

The def was placed in the instructional stance for the Walk & Turn and given instructions. The def stated that they understood my instructions. Subject could not maintain his balance while placed in the instructional position. He swayed and ultimately abandoned the position. During this evaluation he failed to touch heel to toe, he stepped off the line. He did not keep his arms by his side as instructed. He turned improperly and asked for additional instructions prior to his turn. On his turn he spun in one motion and lost his balance. He was not satisfied with his performance and volunteered to try it again. On his second attempt he failed to keep his arms by his side. He did not touch heel to toe and he could not maintain his balance while walking on the line.

**ONE LEG STAND:**

The def was placed in the instructional stance for the One Leg Stand and given instructions. The def stated that they understood my instructions. Subject swayed while standing. He began hopping, counter leaning in an effort to keep his balance. He also raised his arms away from his side.

**FINGER TO NOSE:**

The def was placed in the instructional stance for the Finger to Nose and given instructions. The def stated that they understood my instructions. Subject swayed during this evaluation. He did not keep his eyes closed. He failed to touch the tip of his finger to the tip of his nose on all six attempts. Rather, he touched underneath his nose on the side. He failed to return his arms to his after touching his nose..
