
the caller, who verbally identified himself to be Eric Gitler. Officer Castineira read Eric his Miranda Warnings from a preprinted card, which Eric advised he understood and wished to speak to officers. Eric advised that earlier in the evening he tracked his ex-girlfriend, who he is still dating, to Jumby Bay in Jupiter, Florida. Gitler advised that upon arriving there, he met with his ex-girlfriend Margaret Paulick. Gitler advised that Paulick was drinking, which he advised is against the rules of their therapy, that they are both attending. Gitler stated that he got mad, and left Jumby Bay and went to the beach to cool off. Gitler then stated he received a text message from Paulick asking him to come to her apartment in unincorporated Palm Beach Gardens, which Gitler did. Gitler stated that upon arrival at Paulick's apartment he and Paulick sat down and had a conversation. Gitler stated that the conversation was going well, but quickly changed its tone and became aggressive. Gitler advised at this point he left Paulick's apartment and returned to his home at 2517 25th Lane. Gitler stated that he then began to receive text messages from Paulick, which he let me see, that were angry in nature. In the messages Paulick advised Gitler that she would slap him the next time she see's him, as well as the fact that she was traveling to his apartment at that time. Gitler advised shortly after receiving the text he fell asleep and was woken up to a pounding on his front door. When Gitler got up and checked his door, Paulick was there screaming to let her in. Gitler advised he opened the door, and Paulick made her way inside. While inside of the apartment Paulick and Gitler began arguing again. Gitler advised that Paulick became enraged and slapped in the face. Paulick stated he then grabbed Paulick, to stop her from striking him, and dragged her outside of his house. Gitler stated that Paulick again came inside the house and started yelling at him. Gitler then stepped outside onto his front porch to get away from Paulick. Via an outdoor camera that Gitler has, you can see Paulick come outside to the patio after Gitler and observe her still yelling at him. Paulick then picks up a jug of anti-freeze and strikes Gitler multiple times. Gitler advised he then removed himself from the patio, called police and waited in the parking lot for police to arrive. Upon inspecting Gitler for injuries, he had small welts and scratches all over his chest and back. Gitler refused medical attention on scene.

While Officer Koegel spoke with Paulick, I spoke with Paulick's friend who was identified by her Florida Driver's License to be McKensie Pettyjohn. Pettyjohn advised that Paulick and Gitler did get into a verbal altercation at Jumby Bay. Pettyjohn advised Gitler did come to Paulick's apartment and they did have a civil conversation, but that it quickly became aggressive, and Gitler left. Pettyjohn advised that she and Paulick then decided to go to McDonald's for food, and Paulick and Gitler were having an argument via text messages. Pettyjohn advised that Gitler suddenly stopped responding in the conversation, and Paulick decide to go to his apartment. Pettyjohn advised she did hear both Paulick and Gitler yelling at one another at Gitler's apartment but did not see any physical altercation due to her staying in the car at Gitler's apartment.

I then spoke with Paulick, who was read her Miranda Warnings by Officer Castineira as well. Paulick advised she understood her rights and wished to speak with me. Paulick told me that she and Pettyjohn went to Jumby Bay for a few drinks, even though she knows she's not supposed to per her therapy. Paulick stated that Gitler showed up at Jumby Bay, but that she never told him that she was going to be there. Paulick stated that Gitler showing up, unannounced, upset her, which led to her and Gitler getting into an argument. Paulick stated that Gitler left, and shortly after, so did she and Pettyjohn. Paulick stated that she and Gitler began to text message one another and Gitler agreed to come to her apartment. Upon Gitler's arrival Paulick advised that they began to have a civil conversation that quickly turned aggressive. Paulick stated that Gitler left her apartment, and she and Pettyjohn left to go to McDonalds. While traveling to McDonalds Paulick stated that Gitler and she began to text again, which escalated Paulick's anger. Paulick stated that she then decided to go to Gitler's apartment, and began to bang on his door, when he would not answer his phone. Paulick stated that Gitler answered the door, and she entered without his permission. Paulick stated

she began to yell at Gitler and the argument quickly escalated. Paulick stated that she became enraged and slapped Gitler in the face. Paulick stated that Gitler then grabbed her and pulled her out of his apartment. The argument continued outside, but then went back into the apartment. Paulick stated that Gitler then walked back outside to the patio and she followed. Paulick stated that she did not remember much after that, due to her being so mad. I then asked Paulick if she struck Gitler with a bottle of anti-freeze, and she stated that she did but that it was because she was as mad as she was. Paulick did have some minor abrasions on her legs, which were consistent to her being dragged out of the apartment. Paulick refused medical treatment.

Based on my investigation, statements, and video, Margaret Paulick has been placed under arrest and is being charged with one count of Domestic Battery - Simple for violating F.S.S. 784.03(1)(A)(1).
