 On the **16** day of **March**, **2018** at **13:39** (Specifically include facts constituting cause for arrest.)

ON MARCH 16, 2018 I RESPONDED TO PB ATHLETIC WEAR AND YOGA STUDIO LOCATED AT 4767 PGA BLVD. PALM BEACH GARDENS, FL. 33410 REFERENCE TO A DELAYED SHOPLIFTING.

UPON MY ARRIVAL, I MET WITH REPORTING PERSON LEMOINE, KRISTEN WHO ADVISED THAT ONE OF HER CUSTOMERS WHO SHE PERSONAL KNOWS ( SUSPECT MARIA FADEN ) WAS SEEN SELECTING SEVERAL PIECES OF YOGA WEAR ON THEIR SECURITY CAMERA. LEMOINE STATED FADEN TAKES YOGA CLASSES AT HER STUDIO REGULARLY.

LEMOINE ADVISED SHE NOTICED SEVERAL PIECES OF CLOTHING MISSING AFTER THE CLASS AND REVIEWED HER SECURITY CAMERA AND POSITIVELY I.D. FADEN AS THE SAME PERSON TAKING THE ITEMS AND EXITING HER STORE WITHOUT PAYING FOR THE CLOTHING. LEMOINE STATED SHE CONTACTED FADEN VIA-PHONE IN MY PRESENCE AND ASKED HER ABOUT THE CLOTHING SHE TOOK. FADEN ADMITTED TO TAKING THE ITEMS AND STATED SHE WAS PLANNING ON RETURNING TO PAY FOR THEM AND ADVISED SHE WAS ON HER WAY. FADEN RESPONDED BACK TO THE YOGA STUDIO WITH THREE PIECES OF CLOTHING. LEMOINE ASKED HER FOR THE REST OF THE CLOTHING AND FADEN STATED SHE ONLY TOOK THOSE ITEMS WHICH SHE RETURNED.

LEMOINE STATED FADEN IS SEEN ON CAMERA TAKING THE ITEMS OFF THE RACK AND THEN BRINGING THEM IN THE CHANGING ROOM. FADEN THEN COMES OUT OF THE ROOM WITH HER JACKET OFF AND THE ITEMS WRAPPED IN HER JACKET. LEMOINE STATED FADEN EXITS THE STORE THEN RETURNS WITHOUT THE ITEMS ( VALUED AT \$500.00 DOLLARS ) FADEN THEN PROCEEDS TO TAKE THE YOGA CLASS AND PAY FOR THE CLASS WITH A CHECK AND MADE NO ATTEMPT TO TELL LEMOINE OR THE OTHER EMPLOYEES THAT SHE TOOK THE ITEMS OR PAY FOR THE ITEMS.

POST MIRANDA ON MY BWC, I ASKED FADEN WHAT HAD OCCURRED TODAY AND SHE STATED THAT SHE DID TAKE THREE ITEMS HOME TO TRY THEM ON BECAUSE SHE WAS UNSURE OF THE SIZE, SHE NEEDED FOR A GIFT. FADEN STATED SHE ONLY TOOK THE THREE ITEMS AND WAS COMING BACK TO PAY FOR THEM BECAUSE SHE ONLY HAD ONE CHECK ON HER THIS MORNING AND HAD TO HURRY HOME



BECAUSE SHE HAD AN EMERGENCY WITH HER PLUMPING. FADEN WAS ASKED WHERE THE REST OF THE CLOTHING THAT SHE IS SEEN TAKING ON VIDEO WAS AND SHE STATED SHE DID NOT HAVE ANY OTHER CLOTHING.

LEMOINE ADVISED SHE STILL HAD FIVE OTHER PIECES OF CLOTHING MISSING VALUED AT \$356.00, THE THREE ITEMS SHE RETURNED WERE VALUED AT \$144.00. LEMOINE STATED SHE DID NOT GIVE FADEN PERMISSION TO TAKE ANYTHING FROM THE STORE AND WOULD PROSECUTE FOR THE RETAIL THEFT.

DUE TO THE FACT THAT FADEN POST-MIRANDA ADMITTED TO TAKING THE ITEMS AND SHE DID NOT HAVE PERMISSION TO DO SO AND IS SEEN ON VIDEO LEAVING THE STORE WITH THE CONCEALED ITEMS. I BELIEVE THERE IS PROBABLE CAUSE TO CHARGE FADEN WITH 812.015(8) THEFT - THEFT RETAIL/ OVER \$300. FADEN WAS PLACED UNDER ARREST AND TRANSPORTED TO THE PALM BEACH GARDENS POLICE DEPARTMENT THEN THE PALM BEACH COUNTY JAIL. BWC USED DURING THIS INVESTIGATION.
