

I responded to the area of the intersection of Orange Blvd and Seminole Pratt Whitney Rd in unincorporated Loxahatchee FL 33470 in reference to a possible drunk driver. The complainant stated to dispatch that they were following a gray Toyota north on Seminole Pratt Whitney Rd, and they believed the driver might be drunk.

I caught up with the suspect vehicle and the complainant just south of the intersection of Orange Blvd and Seminole Pratt Whitney Rd. When I pulled up behind the suspect vehicle, a gray Toyota Corolla bearing Florida tag J680DW, the vehicle was traveling north in the left lane. The driver of the vehicle was unable to maintain a single lane and drove over the the line into the right lane of travel. The vehicle drove over the line on the right side of the road two more times, and then crossed over the center line.

I conducted a traffic stop on the vehicle at the intersection of Keylime Blvd, and Seminole Pratt Whitney Rd. When I approached the driver side window the driver rolled down the back window, and needed to be told to put the front window down. The driver who was later identified by her Florida Drivers License as Maria Plesca was crying and covering her face. There was very loud music playing in the car. I asked Ms Plesca why she was crying and to turn down the music. After approximately one minute of trying to get Ms Plesca to turn the music off I reached into the car and pushed the volume button on the steering wheel, and turned it off.

I then asked Ms Plesca to step out of the vehicle. I smelled an odor of an unknown alcoholic beverage coming from Ms Plesca. Ms Plesca's eyes were blood shot, and glassy. This investigation was then turned over to DUI Investigator C. Ficarra ID 8368.

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 04/30/2017 at approximately 0110 hours I responded to the area of 16033 Key Lime Blvd, in unincorporated Palm Beach County, in reference to a DUI investigation. Prior to my arrival PBSO dispatch received a complaint from a witness, Taylor Oblow, who stated she observed a possible drunk driver driving north on Seminole Pratt Whitney Road. Upon my arrival on scene I observed a gray Toyota Corolla bearing Florida tag J680DW stopped in front of a marked PBSO patrol vehicle on the northside of Key Lime Blvd facing westbound. The complainant's vehicle was stopped behind the first patrol vehicle. I observed sitting in the driver's seat of the Toyota was a white female wearing a black dress. I then spoke with the complainant, Taylor, who stated to me the following: the vehicle she was following swerved from its travel lane into Taylor's travel lane. The vehicle went up on a curb then back into its travel lane. The vehicle was then in the middle of the road for a little while. The vehicle was at a red light that turned green but did not immediately begin to drive. The vehicle did not move for approximately 10 to 12 seconds. Taylor maintained visual contact but for a few seconds when she talked to a deputy on the side of the road before following behind the Toyota again. Taylor filled out a sworn statement regarding the incident (see attached for further). I then spoke with the stopping deputy, Deputy Sinnott ID: 23163, who stated to me the following: the driver and registered owner of the Toyota, Maria Rus Plesca who was identified by her Florida issued driver's license, had bloodshot glassy eyes, the odor of an alcoholic beverage coming from her breath. She was difficult to talk to at first because she was hysterically crying and had her music turned all the way up. Maria would not turn the music down and after multiple attempts to have her do so D/S Sinnott had to physically turn the music down so that he would assess what was possibly wrong with Maria.

OBSERVATION OF DRIVER:

Maria was observed to be emotional and have mood swings. D/S Sinnott stated that during his observation of Maria's driving pattern he observed the Toyota cross the right side roadway lines twice and back over the center line. She had appeared to be swerving. Deputy Sinnott filled out a sworn probable cause affidavit regarding the incident (see attached for further). I then made contact with Maria who was still sitting in the driver's seat of the Toyota. I observed that she was hunched over in the seat and her clothing appeared disheveled and unkempt (dress off of one shoulder). Her hair also appeared messy. Maria's eyes appeared red, glassy, and droopy. Her face also appeared droopy. I immediately observed the obvious odor of an unknown alcoholic beverage coming from the vehicle but I did not observe any open containers of alcohol. The radio was on at that time as well. I asked Maria if she was okay to which she stated yea. I identified myself to Maria and asked her if she needed Fire Rescue which she mumbled that she did not. Maria appeared to be weeping at that time stating that she was upset because her son was going to college in Iowa. As Maria spoke I observed the obvious odor of an unknown alcoholic beverage coming from her breath. I asked Maria if she had any medical issues such as diabetes or seizures to which she stated that she worked for a doctor, had her blood taken recently, and was good. As Maria spoke I observed through her Romanian accent that her speech was slurred, mumbled, and thick. Maria stated that she was at a get together at a friends house that night. I asked Maria to step out of her vehicle so that I could speak with her. As soon as Maria exited the vehicle she bent slightly forward putting her hands out to the side and stating, "Wow!" I again asked Maria if she needed Fire Rescue for anything to which she stated she was just emotional. I observed that as Maria stood still she had a slight side to side sway. I also observed that she was wearing pink approximately 2 to 3 inch high heels. As Maria stood close to me and spoke I could still smell the obvious odor of an unknown alcoholic beverage on her breath as she spoke.

DRIVER'S STATEMENTS:

I asked Maria if she had any physical defects or injuries to which she stated she had her blood work and was fine. I asked Maria if she had any issues with her eyes normally which she stated she did not but she cried all day. Maria stated that she was working all day long and was with her friend. Maria stated that she did not normally slur or mumbled her speech but had a Romanian accent. I informed Maria that I could smell the obvious odor of an unknown alcoholic beverage on her breath and asked her how much she had to drink that night. Maria stated that she did not drink anything. I continued to explain my concerns to Maria. Maria stated that she got lost in Wellington. She stated that she worked in Wellington. Maria stated that she got lost coming out of her friends house. She also stated that she did not wear glasses or contacts. I asked Maria if she would submit to standardized field sobriety tasks. Maria tried to divert her answer. Maria stated that she was fine. I again explained my concerns to Maria. She asked what the tasks meant at which time I explained to her what they were. Maria stated she would do the tasks. I asked Maria if she wanted to remove her heels to the tasks which she did. I observed that she lost balance while taking her right heel off. I had to catch Maria from falling. At that time I observed that Maria's muscle tone appeared flaccid (loose and soft). It should be noted that throughout the tasks Maria appeared carefree and indifferent appearing to not be taking the tasks seriously at times.

ODORS:

The obvious odor of an unknown alcoholic beverage on her breath as she spoke

GENERAL OBSERVATIONS

SPEECH: Slurred, mumbled, thick

ATTITUDE: Carefree, indifferent, joking

CLOTHING: Black dress, pink heels

MEDICAL/OTHER: No medical issues (no diabetes or seizures), no physical defects or injuries, no issues with eyes and did not wear glasses or contacts, no medication taken (spontaneously uttered during breath test: takes alot of pills for health issues which make her tired), stated had nothing to drink

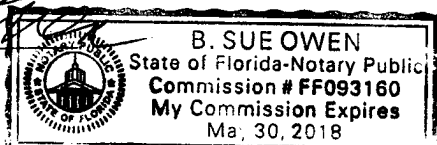

Other Observations:

The overhead blue police lights were turned off prior to the tasks. A yellow tape line was placed on the ground prior to the tasks. Maria was asked to place it on the ground at her feet and place her left foot on it. Maria had difficulty doing so. She pointed her left toes out and placed the tape on her foot before doing as she was asked. Maria's eyes tracked equally, the pupils were the same size and appropriate for the lighting conditions, and no resting nystagmus was observed. Vertical gaze nystagmus was administered and was observed. Lack of convergence was administered and was observed. Her right eye began to converge inward but shot out to the side with her left eye converging normally. Maria had to be told again to follow the stimulus with her eyes only and not move her head because she moved her head during the task. Maria had a side to side sway during the task.

WALK & TURN:

I explained and demonstrated the instructions for the walk and turn task to Maria who stated that she understood. During the task I observed that Maria had the following cues: couldn't keep balance while listening to instructions (moved left foot off line, moved arms up); started too soon multiple times then put right left foot in front of right; did not begin when instructed (had to be told to start twice); stops walking to steady self/regain balance on step four on first return set; missed heel-to-toe on 7 steps on first set then on 9 sets on the second set (including her first attempt at return set); stepped off the line on steps: 10th step was off end of line on first set then on 4th and 5th step on first attempt at return set; used arms for balance throughout task; improper turn (made high ballerina type kick putting her arms in the air and turned without keeping front foot on ground); took incorrect number of steps: 10 on first set then off line on 11 on second set (on second set she took four steps then went back to the beginning and restarted); swayed while standing in instructed position; started with left foot in front not right as instructed; did not count steps as instructed.

ONE LEG STAND:

I explained and demonstrated the instructions for the one leg stand task to Maria who stated that she understood after being explained that task twice. During the task I observed that Maria had the following cues: used arms for balance throughout task; put foot down twice (before 30 seconds); moved from instructed position (raised arms); started too soon by lifting leg six different time. It should be noted that Maria did a ballerina type move by kicking her leg back behind her and lifting her arms up after the task was completed. She stated that she would do a flip.

FINGER TO NOSE:

I explained and demonstrated the instructions for the finger to nose task to Maria. I explained what is considered the tip of the finger and tip of the nose to Maria who stated that she understood. Maria knew her left from her right. During the task I observed that Maria had the following cues: tilted head back and closed eyes before being told to do so; touched nose before being told to multiple times; swayed side to side while balancing; failed to return arms to the side on each instructed hand; never touched her nose with her fingers during the task but brought her hand in front of her face with her finger point to the sky; used wrong hand for task (brought up left when called for right before switching to her right). After task was completed she asked if I had music because she wanted to dance and the tasks were boring.

ROMBERG ALPHABET:

I explained and demonstrated the instructions for the Romberg with recitation task to Maria who stated that she understood. Maria stated that he knew her alphabet in Romanian so I asked her to count from 1 to 50 which she stated she could. During the task I observed that Maria had the following cues: swayed side to side while standing in instructed position; moved arms from instructed position during instructions; incorrectly recites numbers: counted to 10 then paused, counted to 19 then paused, counted 24 twice, counted to 49 then started counting backwards before she stopped herself; opened eyes before being told to do so. The modified Romberg balance was explained and demonstrated to Maria who stated that she understood. Maria was asked to estimate the passage of 30 seconds in their head. Maria showed the following cues: moved from instructed position by raising her hands; closed eyes and tilted head back before being told to do so; estimated 29 seconds as 30; began bending at knees, flapping her arms, and curling her biceps to keep count.
