On February 12, 2018 at approximately 1345 hours while working a Palm Beach County Sheriff's Office permit at Walmart, 101 N. Congress Avenue Incorporated Lake Park, Florida, I was approached by an employee in reference to possible shoplifting.

The employee stated the defendant, Maria Smith, had a shopping cart full of items but her receipt showed only a few items. The defendant proceeded to the money center while the employee took her cart to customer service. A short time later the defendant sat down on another cart near self checkout at which time I made contact with her. The defendant was immediately confrontational and stated "go look at my other fucking receipt." I explained to her that her items were at customer service and if she wanted them she would need to walk over there. She became more aggressive, threw a handful of gift cards striking me on my right foot and stood up. After standing up she lifted her hand and got closer to me as though she was going to strike me in the face. I grabbed both of her arms and provided numerous commands for her to stop resisting. She kept her arms stiff, hands clinched and refused to listen. At which time I held her against the register and she struck her head on the register yelling "stop hitting me." She raised one of her legs as though she was going to kick me and attempted to pull away from the register in the direction of the exit. I held both her arms and spun around escorting her to the ground. Once on the ground she continued resisting trying to grab my hand and scratch me at which time she was placed into handcuffs. I told her numerous times to remain on the ground and she continued to try and lift her legs up, however she was unable to.

This incident was witnessed by asset protection employee, Cathy Odbo, and recorded on security footage.

Once inside the patrol vehicle the defendant continued to kick and spit inside the vehicle.

Based on the above stated information the defendant, Maria Smith, did violate F.S.S. 784.07.2b; Battery(Law Enforcement Officer) and F.S.S. 843.02; Resisting(Without Violence). This offense did occur in Palm Beach County, Florida.
