Schuck advised that his live-in girlfriend (De Gasperi) had started a verbal disturbance with him after she had been drinking on the night of the incident. As De Gasperi's behavior became increasingly aggressive toward him, he began recording her on his cellphone. Schuck advised that this made De Gasperi angry and she began scratching him, pulling on his t-shirt, and attempting to take his phone from his hand. Schuck had multiple scratch marks on his face and neck area, and the neck area of his t-shirt was stretched, corroborating his accounts of the incident.

Brooke Parker was also on scene and she advised that as she and Schuck were trying to leave, De Gasperi continually grabbed Parker by her right arm, and pulled her by the hair, attempting to prevent them from leaving.

Ofc Rekdahl was also on scene and he advised that De Gasperi told him that she had drank about 6 Coronas and that they were just arguing about nothing. She told Ofc Rekdahl that they always argue when they drink. De Gasperi never alleged any physical contact from Schuck, and she also had no visible injuries.

Based on the above facts, I find probable cause to charge De Gasperi with (1) count of Simple Battery (Domestic) (FSS 784.03(1)).


