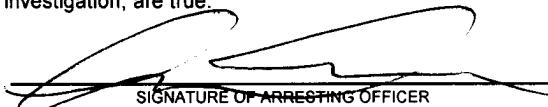

While speaking with Derrin, he stated that they were at a friend's house drinking alcohol when Rosario fell asleep. Derrin stated a friend drove them home. While on the way home, he stated Rosario began to scream and became verbally violent. No physical altercation occurred at this time. Both parties arrived at the above address and continued to argue. While in the kitchen, Derrin stated Rosario grabbed his throat and attempted to strike him in his face. Derrin stated Rosario did strike him one time in the forehead. Derrin did have a red mark on his forehead, which was photographed. After Rosario left the kitchen, she continued upstairs, grabbed a golf club, and began verbally threatening Derrin. Derrin took the golf club away from Rosario and stored it in his vehicle, at which time Rosario returned upstairs and acquired a second golf club. Rosario and Derrin continued to verbally argue inside the residence. Derrin stated Rosario walked outside. While inside, Derrin heard two windows being smashed in the front office room. Derrin is unsure what was used to break the glass but stated Rosario was the subject who broke the glass.

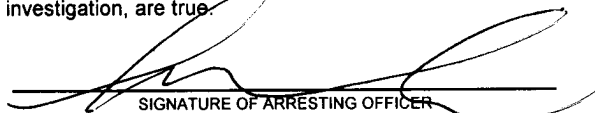
I then spoke with Rosario, who stated she was at a friend's house and fell asleep. While on the way back to 177 Queens Ln, Derrin and Rosario began to argue. They arrived back at the above residence and continued to argue; at which time Rosario stated she went up to her room and wanted to go to sleep. Rosario stated Derrin followed her up to her room and took her cell phone. Rosario stated she grabbed a golf club for self-defense. They went downstairs into the office area where they continued to argue. Rosario stated Derrin moved her out of the way and grabbed the golf club from her and stored it in his vehicle. Rosario then grabbed an additional golf club. Rosario then called 911. Rosario stated she did not enter the kitchen and did not strike Derrin.

Also in the residence was W/M Ralph V. Clark DOB: 12/21/1951. Clark was with both subjects while the altercation occurred. Clark stated while on the way home from the party, Rosario began arguing with Derrin and when they returned to the residence continued to verbally argue. While Rosario and Derrin were in the kitchen, Clark observed Rosario strike Derrin in the face with an open hand and continued to argue. Clark then observed Rosario walk downstairs with a golf club and after Derrin removed the golf club from Rosario's hands, she returned back upstairs and acquired a second golf club. Clark stated that they continued to argue and Rosario later called 911. Clark then stated while Derrin and himself were inside he heard glass break from the office window. At this time Clark state Rosario was the only one outside of the residence.

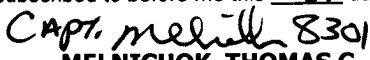
Rosario was determined the primary aggressor. Based on the facts of this investigation, probable cause exists to arrest Marilyn Rosario with Domestic Battery in pursuant to F.S.S. 784.03(1).
