# D.U.I. PROBABLE CAUSE AFFIDAVIT

## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On Saturday, September 21, 2019, at approximately 0217hrs, I was on a proactive DUI saturation patrol in the 5000 block of S. Dixie Highway within the city of West Palm Beach, County of Palm Beach, Florida. I observed a white Ford F-150 pick up truck, bearing FL Tag 398PPS, driving northbound on S. Dixie Highway at approximately 15 miles per hour below the posted 35mph speed limit. The truck would repeatedly drift to the right shoulder then would abruptly jerk the vehicle left back towards center. I also observed he had erratic braking. The vehicle continued this pattern for approximately half a mile. Concerned for the driver's safety and well-being, I activated my overhead lights to conduct a traffic stop.

## OBSERVATION OF DRIVER:

I made contact with the driver, verbally identified as Mario Noriega Santizo, had bloodshot eyes, was slurring his words and was emitting a strong odor of an unknown alcoholic beverage from his breath. I advised Mario for the reason for the traffic stop and asked if he had any medical issues. Mario said he did not and was in excellent health. I asked him to step out of the vehicle to perform some field sobriety tasks and he agreed.

## DRIVER'S STATEMENTS:

I asked Mario if he had anything to drink and he admitted to having 1 beer tonight. I asked Mario if he had any medical issues, issues with his eyes, had any recent head trauma or if he's had any surgery on his waist or his legs. Mario said he didn't have any issues and was in perfect health. I asked him if he wore prescription glasses or if he had any prescription medication. He said he did not.

## ODORS:

Obvious odor of an unknown alcoholic beverage

## GENERAL OBSERVATIONS

SPEECH: Slurred, slow and unclear

ATTITUDE: Calm, evasive and would repetitive comments,

CLOTHING: Black and grey button up shirt, blue jeans and brown boots

MEDICAL/OTHER: Mario was adamant about being in perfect health and did not have any medical conditions nor was prescribed any medications by a doctor.

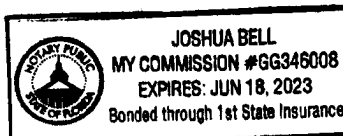

**Other Observations:**

Swaying back and forth. Lethargic movements and mannerisms. Unable to focus on the task at hand. Unable to keep his eyes focused on the stimulus.

**WALK & TURN:**

I positioned Mario on a painted white line which was on a smooth and level surface, free of any debris and well lit by the headlights on my vehicle and nearby street lighting. I instructed Mario to place his left foot on the line and his right foot in front of the left touching heel to toe. I instructed him that he was to keep his hands at his side and stay in this position until I instructed him to do otherwise. Mario had issues placing his feet on the line and continued to do the opposite of what I asked him. I attempted to physically place his feet on the line and put him in the starting position but he would eventually move his feet apart and fall out of position. Due to the driver's impaired nature and inability to follow direction, I was concerned he may fall and opted to move onto the next exercise.

**ONE LEG STAND:**

I placed Mario with his feet together and arms at his side. I demonstrated the task as I verbally instructed him to raise one of his feet approximately six inches off of the ground, point his toe upwards, look at the raised foot, and count out loud 1001, 1002, 1003 and so on until told to stop. I asked him if he understood the instructions and demonstration I provided. He said he did but would then start to talk about how he messed up by giving someone a ride home. I repeated the instructions multiple times and Mario would revert back to speaking to me about things unrelated to the tasks. I gave Mario Terry Warnings and asked him one last time if he wanted to perform the instructions. I advised an answer other than yes or no would constitute a refusal. Mario refused to answer the questions multiple times so I opted to end the tasks and take Mario into custody.

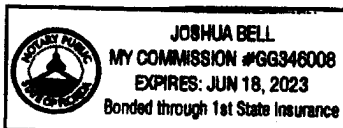
