The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law The Person taken into custody [X] committed the below acts in my presence. [] was observed by who told [] confessed to [] that he/she saw the arrested person commit the below acts. admitting to the below facts. was found to have committed the below acts, resulting from my (described) investigation. On the 3 day of November 20 17 at 0456 [X] A.M [] P.M (Specifically include facts constituting cause for arrest.)

On 11-3-17 at 0456 hours units responded to 8422 Dynasty Dr reference a burglary in progress. While in route units were informed via dispatch the victim calling in lived at 8422 Dynasty Dr. Units were informed the victim observed a slender female enter his black Lexus (Fl#490-YIY) via the rear drivers side door which was unlocked. Victim also observed the female remove his silver laptop from his vehicle. Victim then observe the female enter a silver Chevy Trax (Fl#82GFQ) located at 8426 Dynasty Dr via the rear drivers side door. Upon arrival I observed a female, later identified as Marissa Romano, sitting in the rear drivers side seat of the Chevy Trax (Fl#82GFQ) holding a silver laptop. Romano was detained. I then made contact with victim/caller Renato Isaias who lived at 8422 Dynasty Dr. I also made contact with victim Collin Bender who lived at 8426 Dynasty Dr. Both Isaias and Bender stated Romano did not have permission to enter their vehicles and that they both wanted to pursue charges. Post Miranda Romano admitted to entering the black Lexus without permission and removing a laptop. Romano also admitted to entering the silver Chevy without permission. A silver Apple laptop (\$800.00) (SR #W8916DM88QR) was located inside the silver Chevy. The laptop was later found to belong to Isaias. Based on the above information probable exists to charge Romano with Burglary of a vehicle and Grand Theft. See also case #17-147196 reference victim Bender.
