<p>On 7/28/2018 at approximately 9:36pm I, Officer Tiyaloglu was on patrol in my marked vehicle at the intersection of Northlake Blvd and Interstate 95 Palm Beach Gardens, Palm Beach County, FL 33410. I observed a black vehicle bearing FL tag: RNV60 traveling eastbound on Northlake Blvd with a male occupant seated in the drivers seat. I conducted an FCIC/NCIC query on the vehicle which advised the drivers license of the registered owner was suspended and the tag was expired. I activated my emergency lights and sirens and conducted a traffic stop in the parking lot of 3866 Northlake Blvd (Starbucks Parking Lot). Prior to my approach of the vehicle, my body worn camera was activated.</p> <p>Upon approach, I observed the registered owner/sole occupant of the vehicle later identified as Mark Firestone seated in the drivers seat of the vehicle. I gave a lawful command to provide his license, registration and proof of insurance. While searching for his registration, I observed Firestone's body and hands profusely shaking. I gave a lawful command to Firestone to exit the vehicle to which he complied. I requested consent to search his vehicle and it was granted.</p> <p>I conducted a search of the vehicle and located a "vape pen" which contained a yellow unknown substance in the opening slit just right of the center console of the vehicle. The "vape pen" with the yellow unknown substance was located within direct reach of the wingspan of the driver/sole occupant. Through my training and experience, I identified the yellow unknown substance as suspected THC oil.</p> <p>I field tested the yellow unknown substance with a Marijuana field test kit and the kit revealed a purple color which positively tested for Marijuana. Firestone was placed in handcuffs which were checked for proper spacing and double locked. Officer Stevenson provided Firestone with his Miranda Rights to which he advised he understood. Post Miranda, Firestone advised he took home a stripper and she was smoking it in his vehicle. He stated that the stripper must of dropped the vape pen in his vehicle when she exited the vehicle. Firestone then stated that he does smoke suspected marijuana on</p>

occasion, but the pen was not his.

Upon search of his person, I located a single white pill identified as suspected Xanax from my training and experience in the right pocket of his jeans. When questioned about the pill, Firestone stated that it in fact was Xanax and that he has a prescription for the controlled substance that was located at his residence and not on his person.

Based on my investigation, Firestone was arrested pursuant to F.S.S. 893.13 (6) (A) Drugs-Controlled Substance W/O Prescription (Incl Marijuana) and F.S.S 499.03(1) Unlawful Possession of RX Drugs.
