


On the above date and time, members of District 14 were conducting surveillance at 1500 S. Railroad Ave in the City of Lake Worth in reference on going issues with open air hand to hand drug sale. While conducting surveillance, I observed a white male later identified as Mark Owslany on a black Harley Davidson motorcycle bearing FL Tag MCVI95 pulled up to the intersection of 15th Ave South and Railroad Ave. Mark stopped in the roadway on the south west corner and began speaking with a black female known Prescila Velazquez who I known to be a local drug dealer of heroin and crack cocaine. I observed Mark stop and began a conversation with Prescila as Mark handed Prescila an unknown amount of currency which he handed her in a discrete manner. Prescila who appeared nervous took the money while looking up and down the street to the north and south. Prescila walked directly to the north side of 1501 Railroad and take an unknown item which hidden near utility type cable on the way. Prescila walked directly back to Mark and handed the item to him in a discrete manner trying to keep it cupped in her hand. Once Mark took the item quickly placing it in his front left jeans pocket, he conducted an illegal U-turn in the intersection and preceded south bound on Rail Road Ave.

I followed Mark out of the area and conducted a traffic stop at 812 J. Street where I made contact with Mark. Mark appeared very nervous and his hands were shaking uncontrollably. While talking with Mark he attempted to reach into the front left pocket as to remove something. I told Mark to keep his hands out of his pocket and asked if he had any weapons or anything that would hurt me. Mark replied "No, you can check". I then conducted a pat down of his person and immediately touched what felt like rocks in his front left jeans pocket. Due to my observations and training and experience, I suspected that the rocks were crack cocaine. I recovered the suspected crack cocaine and confirmed with a Cobalt test kit that it was cocaine. Mark was placed under arrest and warned of his Miranda Rights which he stated he understood. While in my marked patrol vehicle #60224, Mark admitted to buying the cocaine for \$20.00 and stated that bought it from the female, who is known to me as Prescila. Mark was processed and TOT Palm Beach County Jail for the possession of crack cocaine. The Cocaine was placed into PBSO evidence.
