On 7/15/19 I was dispatched to 660 Dover St. Apt# 4A in reference to a physical domestic disturbance. BRPD Dispatch advised a female had called 911 and advised her boyfriend had just choked her, there was blood all over her, and he had an unknown weapon in his possession. Upon arrival, I observed W/M Mark Holmberg walking down the hallway of the apartment carrying a suit case and clothes in his hands. Holmberg was bleeding heavily from the head and approached me. I was unable to see if he had any weapons in his immediate possession, so I ordered him to drop all the items. He complied and I asked him to sit on the stairs. I began speaking to him and asked if he was okay due to the blood all over his face. He stated he was fine. I asked if he had any weapons on his person, which he replied, "no". I requested him to stand-up so I could perform a pat-down of his person to ensure he had no concealed weapons. He stood-up and I told him to turn around and place both hands behind his back. I informed him that he was detained and I was placing him into handcuffs while I performed my pat-down. Holmberg yelled, "no, no, no, for what?!" As I grabbed both of his wrists with my hands, to place him into handcuffs, he pulled away both his wrists from my grasp and told me he wasn't going into handcuffs. I was able to maintain control of his right arm with my right hand, but he placed his left hand on the wall and used it to push himself back into my body in an attempt to break free. I verbally informed him, "sir you are being detained, stop resisting". He continued to tense his right arm and pulled away from my grip. At this point, both hands were free from my grasp and he began turning his body towards me. I grabbed his shoulder with my left hand in an attempt to keep him from turning towards me. I was able to re-gain control of his right arm with my right hand while Holmberg continued to tense his arm and pull away from me. I ordered him to lay down on his stomach. He replied, "I'm only going to sit down" and tried pulling away from me. I grabbed his right wrist with my right hand and placed my left hand on his shoulder and while using my momentum, I pulled up on his right hand while pushing down on his left

shoulder and opened my stance. With this motion, he landed face down on the ground with his arms out to his side. I requested assistance on the radio and Ofc. Crowe rushed over to assist. While on the ground, Ofc. Crowe ordered him to place his hands behind his back but he tensed both his arms to prevent us from placing him into handcuffs. I re-adjusted my grip on his wrist and was able to bend his elbow and place his right hand behind his back. Ofc. Crowe then placed his left hand behind his back. With both hands behind his back, I was finally able to successfully place him into handcuffs. I requested Ofc. Castillo, who was now on scene, to stand-by with Holmberg so I could check on the status of the caller, Laura Jackson. I went to apartment 4A and the door was closed but unlocked. I could hear Jackson inside the apartment, yelling for help. I opened the door and observed Jackson lying on the floor with blood all over her t-shirt, hands, and face. She seemed to be disoriented and advised Holmberg had just choked her. She stated that she and Holmberg were arguing in the kitchen when he suddenly ran towards her, grabbed her by the throat, and began squeezing her neck. She stated she was in fear for her life and grabbed the nearest item on the kitchen counter, which was a glass coffee pot, and hit him over the head with it. The pot shattered on his head but he continued to strangle her. Jackson said she lost consciousness two times and somehow ended up lying on the tile floor on her back but doesn't remember how she got there. I was able to see bright red marks on her neck, consistent with her being choked. She was visibly shaken up by the incident and stated her neck and head hurt. BRFD arrived and transported her to Boca Raton Regional Hospital for further evaluation (Run# 2019-009624). Ofc. Bruggeman rode with BRFD to the hospital. I conducted a quick sweep of the apartment and observed a shattered coffee pot on the floor of the kitchen along with blood splatter. I returned to where Holmberg was sitting and spoke to him about the incident. Prior to asking him questions, I read him his Constitutional Warnings from my BRPD issued Miranda Warning card. He stated he wanted to talk to me about what happened. Holmberg stated earlier tonight, he was in the kitchen arguing with Jackson when suddenly, she became irate and charged towards him. He said she grabbed a wooden cutting board from the kitchen and hit him in the head with it. Holmberg said the glass coffee pot somehow ended up broken on the floor while they began fighting. He stated that during their struggle, he grabbed her by the neck and placed her in a "head lock". He refused to elaborate on what his definition of a "head lock" was, but said it didn't involve choking her. I attempted to continue asking him about the incident, but he avoided my questions and just kept saying, "I'm a lawyer and you don't have probable cause to detain me".
