Probable Cause

On 06-05-2019 at approximately 18:55 hours, while patrolling southbound State Road 9 (Interstate 95) north of Military Trail, I observed smoke coming from the northbound side of the roadway. I activated my emergency lights and siren to get to the smoke as quickly as possible. A pedestrian was waving me down to the vehicle and I arrived on scene at approximately 19:00 hours. The pedestrian was later identified as Deputy Nesbitt out of Indian River County. I exited my vehicle and asked if everything was alright. Deputy Nesbitt informed me that the other driver was not alright. The deputy stated that he observed the driver of the vehicle cross lanes of traffic suddenly, hit a concrete median barrier, and continue traveling northbound with no tire. The deputy stated at that point he attempted to position his vehicle in order to stop the vehicle, when I arrived on scene.

I observed a white male wearing a grey shirt, blue jeans, and sandals after talking with the deputy. The deputy stated this male was the driver. I obtained the driver's license and ran it through our dispatch. The license came back to Mark

David Moffitt. I observed the driver sway back and forth, use his vehicle for balance, and stumble prior to my interview of Mr. Moffitt. While speaking to Mr. Moffitt I was able to hear a slur in his voice and Mr. Moffitt was unable to formulate cohesive sentences. I informed Mr. Moffitt of my observations and asked if he would like to perform Standardized Field Sobriety Exercises. Mr. Moffitt agreed to perform the exercises.

I first informed Mr. Moffitt of the instructions and asked if he had any questions. Mr. Moffitt stated he had no questions Mr. Moffitt failed to follow my extended handcuff key without moving his head. Mr. Moffitt's eyes failed to move with smooth pursuit. Mr. Moffitt stated that his head "did not move at all" during the exercise.

I then instructed and demonstrated the walk-and-turn for Mr. Moffitt. I asked Mr. Moffitt if he had any questions and stated he did not. Mr. Moffitt did not start in the proper position. Mr. Moffitt did not walk heel-to-toe. Mr. Moffitt took more than 9 steps in both directions. Mr. Moffitt did not properly turn around. Mr. Moffitt stumbled during the exercise.

I lastly explained and demonstrated the one-leg stand. I again asked Mr. Moffitt if he had any questions. He did not. Mr. Moffitt used his hands for balance, failed to count out loud, and got to 6 seconds before I terminated the exercise for his safety.

At 19:17 hours I placed Mr. Moffitt under arrest for DUI. I searched Mr. Moffitt's pockets incident to arrest and found no contraband. I inventoried Mr. Moffitt's vehicle and towed it from the scene due to the vehicle being rendered useless from Mr. Moffitt's previous driving.

Mr. Moffitt admitted multiple times in my patrol vehicle that he was sorry. Mr. Moffitt also complained that he had to urinate and stated he would urinate in my car. Mr. Moffitt did not urinate in my vehicle.

When I arrived at the jail I read Mr. Moffitt implied consent and asked for a sample of his urine. Mr. Moffitt stated he would refuse urine. I also informed Mr. Moffitt that a refusal would mean losing his license and he stated he still wished to refuse. Refusal time was 19:51pm.

Based on my observations and the refusal to submit to a urine test by Mr. Moffitt I turned him over to Palm Beach County Jail for processing. All events occurred in Palm Beach County. Mr. Moffitt's vehicle was towed from the scene and most of his belongings were left in his vehicle per his request.
