PROBABLE CAUSE

Defendant was driving northbound on 68th Tr N approaching SR706 (Indiantown Rd). I was eastbound on SR706 in the right lane, traveling at approximately 40 mph in a posted 45. I approached the intersection under a stale green signal. As I entered the intersection, defendant rolled through without stopping and turned right into the right lane ahead of me without stopping. I had to brake to avoid running into the rear of defendant's truck. I immediately activated my emergency lights. Defendant continued eastbound, passing several business entrances before stopping in the parking lot of Five Guys, just west of Central Bv. I approached defendant and could immediately smell a noticeable odor of alcoholic beverage impurities. I asked defendant for his DL, which he produced without incident, and for his insurance. I asked him where he was going, and each time he answered, defendant would turn his face away from me. I kept asking him to face me when he talked, but he kept turning away. I asked him how much he'd had to drink and he said none. Defendant's speech was slurred and mumbled.

Defendant got out of his truck at my request. He was unsteady and hesitant when standing and walking. I had to reposition my car as I was blocking a part of the entrance. I had defendant move to the sidewalk in front of Five Guys. I asked him again how much he'd had to drink. Defendant gave a wry smile and said none. I asked him why I could smell it and he said he just drank a beer at the gas station.

I asked defendant to perform FSTs, results as follows:

HGN: swayed front-rear. Eyes very bloodshot & glassy, kept looking around, would/could not follow my pen. Eye movements jerky (no smooth pursuit) both eyes, onset could not be determined because he would no track pen, distinct at maximum deviation in both eyes.

W&T: gave option to remove flip-flops, he kept them on; no steps heel-toe, at least a 3-4" gap on all steps, took 11 steps but counted 9, pivoted on balls of both feet and stepped back & to right as he turned, 10 steps back.

OLS, said he had a bad left knee, so I told him to stand on his right leg, bent knee when raising, swayed front-rear, lowered heel to within 1" of ground but did not put down.

Displayed difficulty or unwillingness to understand and follow directions the entire time. I had to remind him twice to remove his hands from his pockets and keep them out. Effects of alcohol were obvious. I arrested defendant for DUI, handcuffed him and secured him in my car. Defendant was mumbling obscenities under his breath, called me an asshole after I placed him in my car.

Sgt. Robert Given, Jupiter PD stopped with me as I started FSTs. He remained to monitor traffic as a back-up, and said he would wait for North County Towing to remove defendant's truck. JPD case number 17-090571.

I transported defendant to the PBSO BAT where I conducted a 20 minute observation of defendant. We went to test room B with DUI Tech [redacted] Biggs to offer breath test (defendant told me in the car he would not submit). I offered test, defendant refused. I read Implied Consent on camera and defendant still refused. I read Constitutional Warnings and began to question defendant, still on camera. His responses were clipped and sarcastic until he finally said he was done.

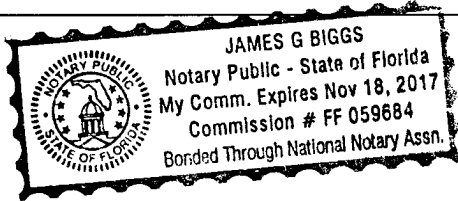

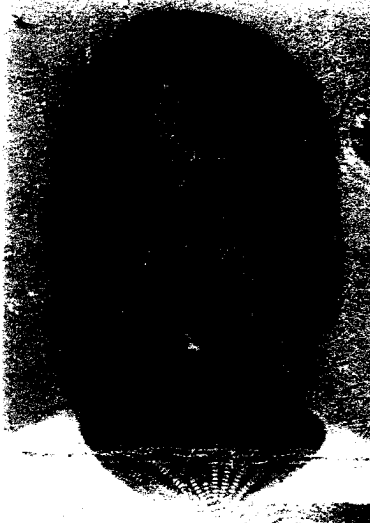
