<p>On 2/22/2017, at 0503 hours I was dispatched to 291 E Boca Raton Rd in reference to a disturbance. Boca Raton Police officers were dispatched four (4) prior times throughout the night. As I pulled up on scene I approached the residence of 291 and saw Mark McDonald sitting on his front porch with his front door open and lights on. I was able to hear his television set from the street as soon as I exited my marked patrol unit.</p> <p>I approached McDonald and asked him what was going on. McDonald said he was just sitting on his porch. I told him I was there because a neighbor called and complained about a disturbance. McDonald began to shout saying "I ain't disturbing anyone's peace!" McDonald told me he was sitting on his property in his million dollar house and yelled at me I was disturbing his peace. McDonald then began swearing at me telling me to, "Get the fuck off of my property!" I then walked over to the complainant, James Rutland at 281 E Boca Raton Rd. Rutland said he called the police several times throughout the night due to McDonald keeping him awake. Rutland said at this point he's willing to write a sworn statement in attempt to have McDonald's actions cease. As I was speaking to Rutland Officer Andrew Crawford arrived as my back up officer. McDonald then exited his porch and walked onto the sidewalk and walked over to 281 E Boca Raton Rd on the sidewalk and began yelling extremely loud.</p> <p>Due to McDonald disturbing the peace and quiet of victim, James Rutland I placed McDonald under arrest. As I attempted to placed the handcuffs on McDonald he began tensing his arms. Officer Crawford and I were able to handcuff McDonald without any further incident. McDonald was transported to Boca Raton Police Department where he was booked then later transported to County jail.</p>
