As the defendant was in the victim's face, the defendant leaned back and head-butted the victim on the forehead. The defendant left the residence after the battery was committed.

The victim and defendant have resided as a single family unit for approximately 12 years.

The act of violence was done intentionally and willfully against the victim's will.

The victim sustained a laceration to the middle of the forehead and refused medical attention on scene. Based upon my investigation I find there to be probable cause on the defendant for Battery victim 65 older.
