Mark stated that he began recording Maria with his cell phone during the argument. Maria then took his cell phone from him. Mark advised me that he scratched Maria on her arm while they were in a struggle over the phone.</p> <p>Next I spoke to Maria who completed a sworn written statement and told me the following: Maria stated that she got into an argument with Mark over finances. Maria stated that Mark began recording her with his cell phone. Maria took the cell phone from Mark. Maria advised me that she and Mark struggled over the cell phone and during the struggle Mark scratched Maria on her left arm.</p> <p>I observed Maria's left arm. Maria had several scratch marks on the inside of her left arm which spanned from her elbow to her wrist. Based on my investigation I have probable cause to charge Mark with Domestic Battery per F.S.S. 784.03(1a1).</p>
