

On 12-29-19 at 12:18am I was dispatched to 321 Waterside Dr. in reference to a domestic disturbance. The caller W/M Niles McIntire called 911 stating he has locked himself inside his girlfriends bedroom because he is afraid of her, and wanted to have Police present to safely leave the residence. Upon arrival W/F Marlene August was inside her home yelling at a closed door where Niles was locked inside. Marlene appeared intoxicated. Lantana PD Officer Harvey was present for backup and was outside. He got Niles attention by shining a flashlight through the bedroom window. Once Niles knew the Police were present, I went up to the room where he was locked inside. Niles exited the room and appeared scared. Niles stated to me "I didn't want to come out, I was in fear for my life". I escorted Niles to the living room area where he started to gather his belongings to leave. Marlene started to calm down, and Niles let Marlene talk to him. Niles and Marlene relocated outside to the porch area with Police present. While outside Marlene was trying to talk Niles into not leaving. Niles then stated he needed to go back inside and retrieve a bag that had his medication in it. Niles entered the residence to look for his bag. Marlene quickly became irritated, aggressive, and started towards the entrance of the residence. I attempted to intervene, but Marlene kept walking and opened the screen door to the residence. Marlene, then saw me following, and shut the screen door on me, attempting to block me from entering the residence. I opened the screen door, then Marlene purposely forced the main door shut on this Officer, hitting me with the door, catching my fingers in the doorjamb. I then applied forward pressure on the door to gain entry to keep the scene safe. Marlene's body weight was on the door. When the pressure was applied to open the door, Marlene lost her balance and fell to the ground, hitting her head on a wall inside the home. Marlene was placed under arrest for battery of a law enforcement Officer, for purposely hitting the Officer with the main door, when forcefully attempting to shut it, preventing me from entering the home to keep the scene safe. When Marlene fell, she received a small cut on her left eyebrow. Boynton Beach Police responded and treated Marlene on scene. She was uncooperative and did not
