**PROBABLE CAUSE**

On December 18, 2017, I was on patrol in Palm Beach County. Dispatch advised me that a collision occurred northbound, Interstate 95, exit ramp to Lantana Road. When I arrived on scene, I observed a gray in color Toyota Camry, with a Florida plate of ESPI24. I observed a white/ Hispanic female, wearing a red shirt and white shorts. I conducted my crash investigation, and once I finished I changed hats, into a DUI investigation. While talking to Mrs. Runge, I observed the odor of an unknown alcoholic beverage emitting from her breath. I also observed that she had blood shot eyes and a slight orbital sway. When she spoke her speech was slurred. I requested that she conduct some field sobriety exercises. She consented.

**Horizontal Gaze Nystagmus**

I checked her eyes and observed equal tracking and equal pupil size. During the exercise, I observed 6 of the 6 possible clues.

- Lack of smooth pursuit, left eye
- Lack of smooth pursuit, right eye
- A distinct and sustained nystagmus at maximum deviation in the left eye
- A distinct and sustained nystagmus at maximum deviation in the right eye
- An onset of nystagmus prior to 45 degrees in the left eye
- An onset of nystagmus prior to 45 degrees in the right eye

During the exercise Mrs. Runge had to be told to stay in the proper position and not to move her head during the exercise. I observed Mrs. Runge to have an orbital sway.

**Walk and Turn Exercise**

The area was level and free of debris. Mrs. Runge indicated that she observed the white painted line on the ground in the parking lot. Mrs. Runge began the exercise too soon and had to be told to wait and to get back into the starting position multiple times. She kept stating that she was not drunk and that she only consumed two Heineken's through out the night. When instructed to start, after counting out loud after step number 4 she stopped counting out loud. She took 12 steps and when turning she did not take a series of small steps around. On the 9th heel to toe steps back, she missed heel to toe on all steps, fell off the line at steps 2,3,7, and 8, and also did not count out loud.

**One Leg Stand Exercise**

During instructions, Mrs. Runge began and raised her right foot before told to start. During the exercise, Mrs. Runge displayed an orbital sway and had to use her arms a few times to keep from losing balance. She raised her arms approximately 12 inches away from her body. She also did not raise his foot six inches off the ground. She raised his foot approximately 4 inches. During the exercise, at times she would stop looking at her feet and look up at me. After approximately 5 seconds of counting out loud, she put down her left foot for balance and raised it again and started dancing. I allowed her to start over. After starting again, after approximately nine seconds she stopped the exercise and said that she was not drunk and that she only had two beers.

**Finger To Nose**

She was instructed to raise his hand in the following order, left, right, left, right, and right, left. She started the exercise during my instructions. After again instructing her and again performing the exercise, she stated she did not understand. Once again, I informed her of the instructions and demonstrated once again. She started stating that she was not drunk and that she was going to sue us. I gave several chances to re start exercise and she ignored me and continued to argue.

At approximately 2:33 AM, I placed Mrs. Runge in handcuffs and under arrest for DUI (F.S. 316.193.). She was searched and then secured in my patrol car. I then transported her to the Palm Beach County Jail. During the whole ride to the jail, she kept stating that I was evil and that she was going to sue me. She repeated said that the other party involved in the crash just wanted her money and that it was not a big deal. Once arrived at the jail, I conducted a twenty minute observation of Mrs. Runge. At no time did she regurgitate or take anything by mouth. She was asked to provide a breath sample on camera. Results as followed.




